Carter Interviews Protestors At NAACP Convention

The following interview was conducted by Larry W. Carter at the 71st Annual Convention of the National Association for the Advancement of Colored People during the demonstration while President Jimmy Carter addressed the convention. Dr. James D. McCullough is one of the leaders of the Coalition for Equal Justice in the City of Miami.

McCullough. We are here sir because there is a very serious situation in Miami. Not only in Miami for the Black people, but all over the United States. Pres. Carter does not seem to understand what the Black people need in this country, what is going with them.

Justice is denied to Black people here in Miami. Unemployment is over 40% with the Black youth in this area.

and they have a right to make a living, an equitable living. That's why we're here sir.

L. Carter: Very good, Dr. McCullough. I can understand and certainly appreciate what you are doing. Let's move to another line of thinking Doctor, there are a good many Black people in the city of Miami. do you feel that this is the kind of turnout you expected for this demonstration.

Dr. McCullough: Well, I think if you would take into consideration the lack of news coverage that was given, let me explain just one thing - how this demonstration would have been public ten times longer with the Black population here in Miami.

On Monday, the headlines in every local newspaper here that there was going to be extreme violence. Would you with that type of headlines, when there was no indication whatsoever that there was violence. The head of these organizations, the coalition for equal justice, for racial justice, had stipulated continuously that this was going to be a peaceful demonstration, but the newspapers, radios, TVs played it up on every day for four consecutive days that there was going to be violence similar to the riots previously.

So naturally the people were scared. After four days of those types of headlines, then the Police Department finally came up and said they had misquoted one of the police people and there was not going to be any violence.

But as you know, the first headline is the one that makes the impact. And this is why we do not have the quantity of people here that we would have normally

had under these circumstances.

L. Carter: Dr. McCullough. We have heard that because the convention is being held here in Miami, there is some feeling of dissatisfaction on the part of the local citizenry, particularly the Black community. Do you have any opinion on this?

Dr. McCullough: I can only tell you this sir. We are not here against the NAACP itself, but I can only ask you the question in return, How many of the administration of the NAACP has met with the local people in the areas that are affected, that's number one? Number two, how many people in the NAACP can explain why the FBI is one of their major exhibitors?

The FBI has a noted history of being one of the organizations that have constantly oppressed Black people and the Civil Rights Movement, the very thing that the NAACP stands for. This is very hard for us to understand. They have an exhibit of the CIA. This is very difficult for me as a Black person to accept. And I think this is one of the things that is very displeasing with the Black people here.

L. Carter: Dr. McCullough, are you suggesting that by and large the NAACP as an institution in the Black community has basically forgotten about the people that it is representing.

Dr. McCullough: My opinion is the NAACP is

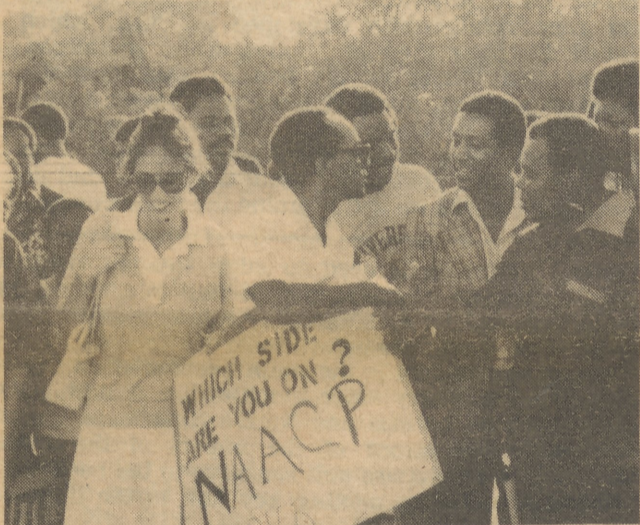
out of step with what the Black people need, what they want, and what they are striving to obtain, sir.

L. Carter: Alright, let me see if I understand what you are saying. The NAACP must be more cognizant of the needs and wants and desires of those persons in the intercity areas that it is purposed to be serving. Is that what you are saying?

Dr. McCullough: Absolutely, sir. That is what we are here for and that is what the NAACP we hope will finally see that is their responsibility also.

L. Carter: OK, then. I know this is going to be a loaded one and I want

IEWS and REVIEWS

The Republicans are gathering to nominate their ultra-conservative Ronald Reagan for president. The man has been saying the same things for years, running against Russia, Cuba, and communism. It looks as if the theme will pay off this time, and we will see the biggest change in federal and state governments since 1932 when Democrats who had been running in vain for years suddenly found themselves elected to office and didn't know what to do about it.

As I recall there were not more than a half a dozen black Democrats in 1932, and even they were so shocked that they literally froze for two years before they began to get themselves together.

That is the way things look for the Republicans

now. I don't claim to be a political analyst, but I do recall mentioning a while back in 1978 that President Carter looked like a one-termer. Well, now he looks more like that than ever.

In my estimation, he stumbled into the nomination because of the events that he had nothing to do with, but was smart enough to play for all they were worth. Otherwise we might have had Ted Kennedy as the presidential candidate, and maybe he might have had a chance to beat Reagan.

But now I just don't see how Carter is going to overcome the negative attitude that people have about him. Blacks say that even if they vote for him this time, it will be not a vote for him, but a vote against Reagan. In spite of what I have been saying about sitting this one out, I might adopt that line myself.

And how will blacks fare under a Reagan presidency. He probably will feel that he doesn't owe them anything and may adopt that policy of what one fellow called benign neglect with as few appointments as he can get away with. Most of his ideas concerning projects that have helped us are opposed by Reagan and he is sure to say all the things that so many people want to hear.

School busing. Opposed to that in order to achieve integration, but where were those voices when busing was enforced to maintain segregation.

Reverse discrimination. How can people who are not in power discriminate? I suppose if the blacks in South Africa wanted to keep whites out of their part of the country, that would be reverse discrimination when they were shoved into that part of the land by force.

One fellow says that all of us blacks should vote for Carter just to keep the other guy out, but I doubt if even that would do much good because too many people are against him. We aren't much more than ten percent of the population and if we all voted, we would just be outvoted.

Now, if things get tight and the election is as close as it was in 1976, we could be a factor if we voted, but somehow I don't think it will be that close this time. A vibrant, forceful speaker might turn things around so he could have a chance, but the present occupant of the White House is neither vibrant or forceful when he speaks. Maybe I have written his obituary too soon. Much as I dislike him, I hope so.

Another election that is important to us is coming up next month. Everybody who wants to see Willie Glanton retain her council seat should get out and vote, because you can bet that everybody who doesn't want her in there will be voting.

If we all vote, maybe we can outnumber them because there are so many that they will likely split up their votes, and a solid front will bring Glanton in.

White Cubans, on the other hand, are almost entirely of Spanish origin. Their population, on the other hand, rose from 66.9 percent of the total in 1899 to 74.3 percent by 1943, due largely to the immigration of nearly a million Spaniards and Canary Island residents between 1900 and 1929.

By 1973, however, this percentage had decreased to 72.8. Throughout the history of the island, the

dominant classes in the Cuban population were recruited primarily from the Europeans and their descendants, white and mestizo, who have monopolized not only the direction of the economy but also the access to culture and education.

The Asian population of Cuba is the result of the interruption of the slave trade in the middle and late nineteenth century. The Cuban-Spanish landlords, due to the need for laborers following that interruption, imported more than 125,000 indentured Chinese workers, primarily Cantonese, between 1853 and 1874 to provide contract services for a period of eight years. Their numbers were reduced to some 14,000 by the time of the census in 1899, due primarily to poor living conditions.

During the 1920's some 30,000 more Cantonese and a few Japanese also arrived. Due to the fact that the individuals imported from China and Japan were exclusively male, there was rapid and heavy intermarriage with the Black, white and mestizo Cuban populations. In Cuba today, however, the

remaining Chinese element in the island's population is aged and is near extinction.

There are geographical pockets of Blacks living throughout Cuba, but in Havana, no more than one-fifth of the population appears to be of Black African extraction in the shades of black and brown normally identified as being Black in the United States. Of the approximately 70 percent of the Cuban population which is brown, with primarily straight or curly hair indicating the characteristics of Blacks, Indians and Spaniards.

It is against just this sort of background that the classic Latin American — Caribbean sort of class and race relationships developed in Cuba, which placed Europeans on top, followed by mulattoes, browns and Blacks on the bottom. One normally would expect that many of those who have recently left Cuba to be the white/ Europeans, with the brown and black residents remaining behind. This has not, quite obviously, been the case, and in succeeding weeks we will examine the reasons why.

A Black Look At Politics

Well, the Republican Party made it official Wednesday night: the 1980 GOP ticket will include Ronald Reagan (to no ones surprise) and George Bush (to the surprise of many).

The convention in Detroit was the scene of some heated battles concerning the Republican party platform. The Equal Rights Amendment, in particular threatened to divide the GOP along ideological lines. Moderates wanted less hard right-wing language on such issues as ERA, abortion, defense spending, and domestic policy. Unfortunately, the conservatives dominated the convention, and rammed through their neo-reactionary views, making the platform the most conservative since 1964.

Most of us know what happened to Barry Goldwater and the GOP in 1964. It was the worst electoral defeat in history until the 1972 McGovern - Nixon contest.

I have already analyzed Ronald Reagan as to what, if any, significance he and his Republican cohorts attach to issues that affect black and poor Americans. While the 1980 GOP platform briefly touches on a few of these subjects, it by and large ignores the topics of affirmative action job training programs for the terminally unemployed, improved public school funding, busing, enforcement of Federal minority hiring laws, and investigation of widespread police brutality complaints in our major cities.

Realistically, it appears quite clear that the Republican party is not concerned at all with the obstacles facing minority voters, nor are they sensitive to the problems confronting America's cities, illustrated by Reagans fumbblings, vague address to a conference of mayors last month.

True, the Carter Administration has not bent over backward to aid blacks in these areas, but at least he has been partially receptive. Republicans seem bent on returning America to the 1950's — and you know there were very few "Happy Days" for black people during the 1950's.

Aside from supporting a naive, and potentially disastrous foreign policy (resembling Teddy Roosevelt's "gun boat diplomacy" of the early 1900's) Republicans think they can ignore the Third World and push the allies around with impunity. The world is much more interdependent than that, and I am sure that, if elected, Reagans foreign policy would

be an unmitigated disaster.

A blanket support for Israel would alienate Arab moderates and radicals alike, and jeopardize U.S. foreign oil supplies. Too much emphasis on competition with the Soviet Union, especially in strategic armaments, would sharply reduce funds available for foreign aid.

This, in turn would ruin what few good relations this country has with Africa and Latin America. The last Republican administration thumbed its nose at the Third World, actually encouraged OPEC to raise oil prices, and faced the world with a dual foreign policy, due to the schizophrenic personality of Henry Kissinger.

The former Secretary of State could never conclude a successful peace treaty in the Middle East because he kept concluding two different agreements — one with each faction.

In any event, perhaps now more than at any other time in U.S. history, blacks must storm the polls in an attempt to stem the conservative (racist) tide that is sweeping the nation. Black Americans gave Jimmy Carter the margin of victory in the dead-heat of the 1976 Presidential race, we can do so again, if sufficiently mobilized.

You can be sure it will be another close election, with Jimmy Carter carrying the South and East, and Ronald Reagan taking the Western and Northern states. Black people make up a large part of the electorate in most of the key states like Michigan, Pennsylvania, New York, Texas, California, Ohio, Illinois, and Maryland.

If we turn out at the polls in November, black voters can provide President Carter with the

"swing" votes he'll need to edge Reagan. White people will be sharply divided, as in 1976, and Independent John Anderson will pull as many votes away from Reagan as he will from Carter.

Voter registration is the main prerequisite in the process of minority voter mobilization. Traditional allies such as Latinos and Native Americans must also be made aware of the import of the 1980 election. Jews who are still sensitive to the needs of colored peoples are another key link in the liberal voting chain.

Few elections have been so clearly demarcated in history, nor so ideologically distinct (at least on minority issues). The choice for black Americans is really no choice at all - we swim with Jimmy Carter, or sink to the bottom with Ronald Reagan whose greatest claim to fame was co - starring in the old "Bonzo" movies with a chimpanzee who was a better actor than he was.

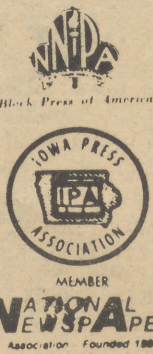

A Female Focus On The Issues

They did murder George Jackson (THE SOLEDAD BROTHERS) Angelas' then lover. Fortunately the bigots on the California Board of Regents (including the likes of Patty Hearst's mother & Ronnie Reagan) did not succeed in their campaign against Angela as Hollywood did against Paul Robeson. to get the facts on it, because we want to take it back out to Iowa where we really don't have all of the facts as to what's going on in these major metropolitan areas where we have a large concentration of Black people.

As you may know, in Des Moines we have just a very few Black people. One of the things I would like to know is do you feel that Roy Innis of the Congress on Racial Equality (CORE) is more in tune and more in sync with what's happening with the everyday Black person than what the NAACP might be.

Dr. McCullough: I wouldn't want to answer that. We have to be very careful that we do not get into the position of divide and conquer. We need every Black person. We need every White person in this struggle for equal justice. We would like to say that Mr. Innis, the members of the NAACP, we believe the rank and file of the NAACP, their hearts are out here. We feel that each person, each leader, so-called leader, must assess themselves.

What is it that the Black people need, what the mechanisms by which we are going to obtain those needs and those votes. Can we not only stand up say that we are speaking for the Black people if we don't

even go out and communicate with the Black people to understand what their needs are. We can't do it from the Fontainebleu.

L. Carter: I understand.

Dr. McCullough: I'll tell you what's going on in Culver City.

L. Carter: I understand. But now do you feel there is an organization within the community, within the Black community, that would represent your particular feelings. And if so, what is that organization, please?

Dr. McCullough: Hopefully here I would say the Coalition for Equal Justice which is a conglomeration of multiple organizations are coming together to fight for justice in this area. And I think that's what's going to have to be done next in line.

L. Carter: Is the NAACP part of that coalition?

Dr. McCullough: No.

L. Carter: How about the Congress on Racial Equality (CORE)?

Dr. McCullough: Yes, it is.

L. Carter: Very well, in your opinion does the Miami NAACP relate to or understand the problems of the grass roots Black.

Dr. McCullough: In my opinion, they do not. That's my opinion.

L. Carter: OK, sir. I appreciate your time and candor, Dr. McCullough. Thank you for the interview. We'll send you copies of the

newspaper. Let me tell you that I think you're speaking from the heart and soul of many Black Americans.

Dr. McCullough: I'm here for one purpose. My people need help. We need help.

L. Carter: But you must understand. I'm a part of your people also.

Dr. McCullough: I understand that. We can't get help unless we help ourselves. We've got to get out here and demand action.

L. Carter: OK. I concur with you. Thank you very much, Dr. McCullough. I

appreciate your efforts down here and believe me my heart pours out to you. Iowa's heart pours out to you in your struggle here in Miami. We shall overcome.

I'm sure, only if we keep this vigilant watch over this community here in Miami that all of America will see that we intend to be, in the words of the late great Dr. Martin Luther King as quoted from the old Negro spiritual, "Free at last, free at last, thank God Almighty, we are free at last." Thank you, Dr. McCullough.

Dr. McCullough: My pleasure.

Foster Grandparent Positions Open

The Foster Grandparent Program is a part of ACTION, the federal agency that oversees volunteer programs, and is sponsored locally by CIRALG. In Des Moines over 40 Foster Grandparents each spend 20 hours a week at 13 local schools and day care centers.

NAACP Investigates Police Use Of Force

LETTER TO EDITOR

In response to the complaint that I have received as President of the Des Moines Branch NAACP concerning the excessive use of force in the arrest of Ricardo Trumbo on July 12, 1980, resulting in his hospitalization, and after conferring with Attorney Robert A. Wright, President of the Iowa Nebraska State Conference of Branches, NAACP, I am directing a committee to make an indepth investigation of this complaint and to make a report of the committee's findings to the branch for further consideration.

I am also directing a letter to Billy Wallace, Chief of Police of the City of Des Moines and to Mr. Richard Wilkey, the City Manager, requesting that the complaint be thoroughly investigated and appropriate action taken in the event the complaint is substantiated.

I have recently returned to this city from the Annual Convention of the National Association for the Advancement of Colored People held in Miami, Florida, the city of racial unrest arising out of confrontations of Black citizens with police and police



brutality. I submit that we certainly do not want this type of response in our city.

In the event the alleged complaint is supported by facts, it may be considered by the NAACP that the Justice Department be requested to use its investigative powers and that the Attorney General of the United States prosecute any officer who violates the rights of our citizens by

the use of excessive force.

The rioting in Miami, was precipitated by the beating death of a black. The complaint alleges that Ricardo Trumbo was severely beaten to unconsciousness and has been hospitalized.

It is our concern for the future race relations of our city that such incidents do not occur.

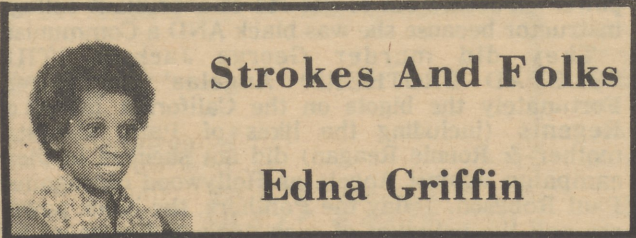

BYSTANDER COLUMNIST ASSUMES DUTIES AS LIBRARY BOARD PRESIDENT IN MUSCATINE, IOWA

There are two kinds of people — those who have the desire to have their obituary read good and those who are just destined to achieve.

For the obituary to look good it was necessary to have been a member of the local Garden Club (if a woman) and President or past president of the Library Board, by these standards you were a prestigious member of the community.

Some sixty - odd years ago a child was born in Centerville, Iowa. She was named Aldeen and with that name went a charge to "keep up" for you see she was a Jones!

As the years went by, she found she possessed a gift or talent, inherited from her father, Schuyler, to

lead, poise and dignity from her mother, Gladiator, and a out - going personality of her own that was going to enable her to at least achieve.

Even though I belonged to the Order of Eastern Stars, the Sue M. Brown club of colored women and the NAACP the most enjoyable years were those spent as Sunday School teacher in the Second Baptist Church. My students are now scattered to many parts of the country — Los Angeles, Kansas City, Texas, Davenport, Moline, Des Moines, etc.

My marriage to William Davis brought new challenges and the consequent birth of our five daughters in the post - depression, post war, area presented even greater challenges.

Because Centerville was discriminatory, prejudice and a segregated community in the '30's it was important that our children knew that the color of ones skin was not as important as the content of his character. It was important that they no the meaning of and practiced tolerance in regards to race, creed and religion.

Thus our children grew to be broadminded and free from stigmatism in spite of Centervilles' "buzzard roost" theatre — that was tolerated, no swimming in the city park pool that was endured and back - door service restaurants that was not patronized.

1948 found the Davis family moving to Muscatine, Iowa a city of 18-20,000 people of which 75 - 80 were black and a city relatively free from prejudice.

I soon became active in the Bethel AME Sunday School and Nora F. Missionary Society but gained most satisfaction from the youth group, that I organized and headed for three years. As the children grew I found myself "joining" and "participating" — Association of Colored Womens Club, PTA, helping with Brownie and Girl Scouts, YWCA board member, member of the city's first Human Rights Comm. member of the Mayors' comm. on Muscatine's parks and recreation.

During the unrest of the sixties became active in "Living Room Dialogues" and a member of our "Know Your Neighbor" panel Muscatine's counter-part to Des Moines famous Know Your Neighbor Panel. Because of Muscatine's large Mex-American population I worked hard for better relation and understanding of minorities.

Because of a long time fascination with Herbs and Spices and their uses I joined a group called "Herb Pals" and shortly thereafter was invited to join the GARDEN CLUB!

And finally in 1977 Evelyn Schauland appointed me to the PM MUSSER LIBRARY BOARD of TRUSTEES and June of this year I was elected and assumed the duties of president of said board!

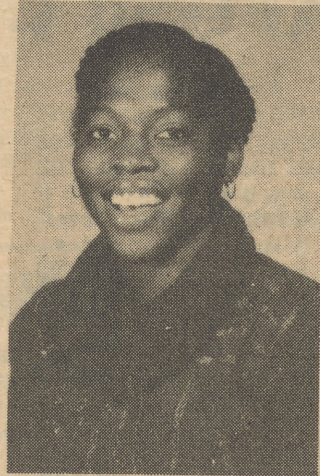

This year, as last, our youth represented Iowa well — DeeAnn Davis was Gold Medal Winner in Dramatics and recipient of \$1,000.

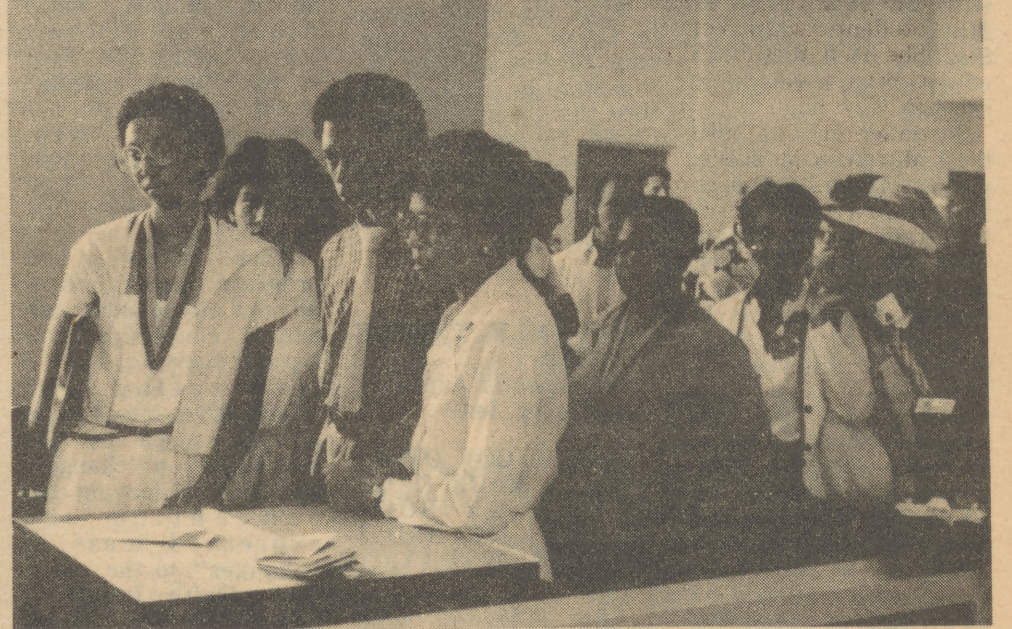

Prudence will be attending Drake University in Applied Music. She graduated from Roosevelt where she was involved in the High School Orchestra.

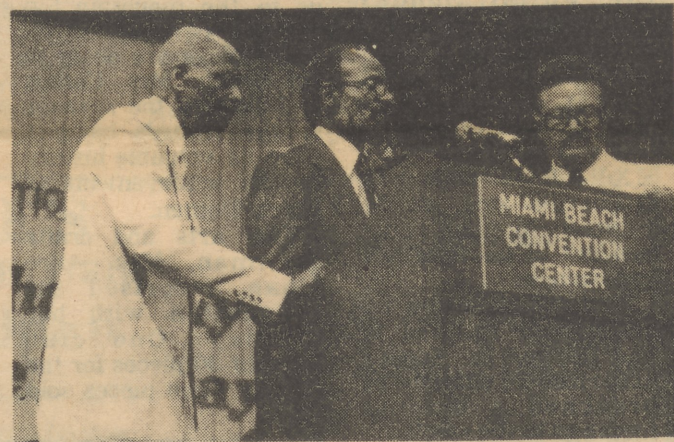

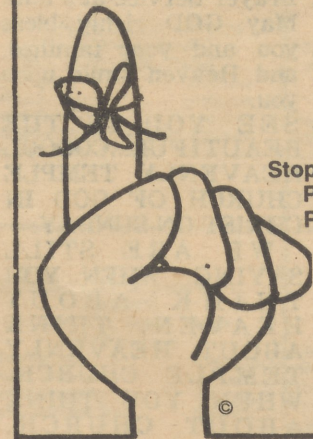

from "R-2" One and Two Family Residence District and "C-1" Neighborhood Retail Commercial District classifications to "R-3" Multiple Family District classification.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

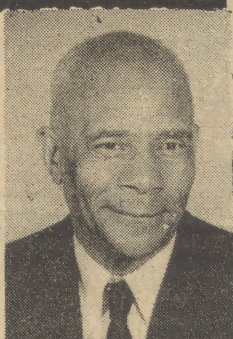

As soon as a spot can be found, former heavyweight champ Muhammad Ali and Larry Holmes will try to settle their differences in the ring. Right now it looks like Las Vegas, but next month it may be a spot in some other country.

Most of the boxing experts and some of who are not so expert think Ali is about as foolish as a person can get by taking his 38 year old body into the ring for even one more time. He can work hard and maybe come into the ring looking in good condition, but that will likely be a shell of the once dazzling boxer.

Then there is the possibility that he might get

injured. Punches to the head don't do anybody of any age any good, and they certainly won't help the former champ.

Holmes has a good left hand and uses it well, in spite of the fact that he doesn't impress one with his speed. But the bout will get the two men around eleven million bucks, so why worry about injuries. When you think that Joe Louis got around a hundred thousand for his title defenses, and often not over fifty thousand, and he is considered by many to be the greatest, you have to wonder what makes all the heavyweights in the game put together worth eleven million.

Preliminary fighters make the money that Jack Johnson received for his title defenses, but then, even if you got thirty thousand, you got to keep all of the dough. Now, to keep thirty thousand, you have to make maybe two or three times that much.

Does Ali really need money that badly? Perhaps he wants it for his Muslim organization, but would I put myself on the line so I might become a washed up fighter with not even a chance to enjoy what I had earned? Boxing is the only game I know of in which the object is to hurt your opponent, render him unconscious or beat him into submission.

Maybe it should be banned, but when you consider that in the days of the old Romans and Greeks, boxers used to have metal gloves like our brass

knuckles and history has it that they would spar for hours before trying to deliver a blow that could be fatal. And has the game gotten very far past that stage today?

Every so often you read about a boxer being taken to the hospital and now and then one dies from head punches. And people don't seem to get excited about it. "That's the breaks." is all most of them seem to say.

Writers will tell you that the fighter knew the chance he was taking when he got into the ring, and it was his fault. Then they tell you about Archie Moore and Joe Walcott, not forgetting Sugar Ray Robinson who was 36 when he finally quit the game, but those people fought often enough to keep their skills sharp, so they didn't have to start from scratch.

Then, both Moore and Walcott had the champ Rocky Marciano, on the ropes and in their prime would have probably beaten his brains out, but they went as far as they could, and when they got walloped around the head, they went out like lights.

That will likely happen to Ali if the fight goes fifteen rounds. How many head punches can he take? Not very many. Oh, well, maybe it won't come off at all because Holmes wants as much as Ali is going to get, and who in hell can raise that kind of dough?

Black Folk In American Civilization

The Black Church As A Central Factor In Afro-American History

Black people arrived in the English mainland colonies in August of 1619. Almost from the date of their arrival differences were made in their treatment in comparison to their European counterparts.

One of the early distinctions made was a ban placed on the baptism of the African. The Anglicans feared that if blacks were baptized they might no longer be able to be forced into bondage. But soon the law was interpreted to fit the situation and blacks were baptized but still remained slaves.

One of the real ironies resulting from this practice occurred in Portsmouth, Virginia in 1792 where Joshua Bishop became pastor of a white church, First Baptist Church. In contrast, in Latin America the Catholic church began its contact with the Africans being imported there by demanding that they be baptized.

And so when we start to look at the Anglo - American church and its relationship with the Africans, it was not one of liberation, but rather one of suppression. The black church has the peculiar task of trying to free people in a world where the larger element has assigned them the roles of slaves.

The white American preaches and theorizes about brotherhood and the equality of mankind as

expressed in the New Testament. And the speeches of our statesmen are on brotherhood and equality while they practice separation and hatred.

One of the causes of the discovery of America was the translation into action of the desire of European zealots to extend their Catholic religion into other parts.

And even though Bishop Las Casas of the Catholic church is, in part, greatly responsible for blacks being used in large numbers as slaves, the Catholic church in South America had by far a more Christ-like interest in the African than did its counterpart, the Protestants of North America.

Blacks organized their churches among themselves as monuments of black pride and self respect for when they first tried to enter and join the white protestant churches, they were rejected.

They made their churches for themselves but to which whites might come and join. Meanwhile, the white church faced and challenged war, crime, intemperance and the world, but rarely the question of race or color. (to be continued)
