## Vote September 9 For Des Moines School Board

Des Moines residents will go to the polls, Tuesday, September 9, to elect two members to the School Board, as well as to vote on a controversial \$6 million tax levy.

Three candidates are running for the two seats on the Board. Two are incumbents — Nolden Gentry, an attorney, of 4303 Wakonda Parkway; and Ray Palis, an insurance company executive, of 3015 S.W. Twenty-ninth Street. A newcomer on the ballot is Greg Nepstad, owner of Forest Realty Corp., who lives at 3116 Thirtieth St.

Highland Park News interviewed the three candidates.

### WHY ARE YOU RUNNING FOR THE SCHOOL BOARD?

Gentry replied that although he had previously indicated he would not run, he changed his mind after becoming involved in the search for the new School Superintendent,

Dr. William Anderson. Gentry said that he is impressed with Dr. Anderson's leadership ability and his experience in dealing with problems similar to what the Des Moines district is facing.

"It should be very interesting to be involved", said Gentry, adding that he feels his own past experience will be useful during the transition to a new superintendent. He said he also feels his background in School Board finance will be helpful now that there will be a substantial reduction in the State funding of school districts.

Palis said, "I feel that I have made a contribution in the three years I have served. I am in a better position now to provide more to the community than when I first began to serve on the Board."

He also noted that he had been involved in the search for the new

superintendent and said, "I want to be part of the Board under Dr. Anderson's leadership."

Nepstad said, "I have been very unhappy with the School Board's major decisions for a long time. I have to do something."

He said he believes that some of the School Board's decisions are hurting the community. Specifically, he said that he thinks the Board's policies on closing schools are working at cross purposes with efforts of those who are

trying to improve and develop the city. Nepstad charged that uncertainty among residents uo which schools will close, is causing "white flight" to the suburbs.

## Dartanyan, Midget: Jazz Artists

A Des Moines East High and Drake University graduate is swinging on high key again. Managing the performing group DARTANYAN and several other successful tour bands, Dartanyan Brown, has joined forces with an artistic saxophone and flute player, Marsha Midget, who happens to be his other half.

Together, on occasions with their 2 year old son, Jaimeo, they travel across the country sharing their talent. For Dartanyan, who is basically a self-taught musician, the strum on the guitar comes from hours of hard work and discipline.

This is not a success story. Success cannot be measured in numbers but in varying degree, levels of self-attainment and hard work. Both Marsha and

Dartanyan could have removed themselves from the Des Moines community and shared their efforts with the New York and Los Angeles scene, but they have chosen to raise a family and create music right here in Iowa.

The interracial marriage does not inhibit the couple from performing, as a duet, and in groups. The love and beauty of their creativity is shared with witnesses of their live performances.

Marsha, a native of Perryville, Missouri comes from a musical family. At age six she sang with her sisters in a jazz vocal group, the VAUNE SISTERS and at twelve she played saxophone in her father's jazz group.

She studied saxophone and piano at Fantbonne College and composition and music theory at Washington University.

Midget has written and composed for several mid-west groups, including the Mid-West Express and DARTANYAN. She is the co-author of a book with Rodger Maxwell, on helping the student sight read jazz rhythms and learning how to play solos. The book will be published in 1981 by C.L. Barnhouse Publications.

Dartanyan has his roots in Des Moines. He is a versatile self-taught musician featured in several mid-west groups on keyboard, guitar, bass and as a vocalist. In 1979 Brown released an album, DARTANYAN. He has also recorded with trumpeter Bill Chase on Epic Records. His musical accomplishments include opening acts for Phoebe Snow, Grover Washington, Kenny Loggins and Ronnie Laws. Recently Brown

served as musical director for an Iowa Public Broadcasting (IPBN) series on Iowa History.

A journalism graduate from Drake University, where he also played in the Jazz band, Brown has used his acquired skills as a free-lance writer for various magazine and newspapers including THE NEW IOWA BYSTANDER.

He studied keyboard with the late Ernest Speck Red.

Newly touring musicians in the Iowa Arts Council Artist-in-Schools Program, Brown and Midget are available to schools and community centers for residencies in jazz and blues. They will be artists-in-residence in the Waterloo School system this fall and have previously performed and taught in the Cedar Rapids district.

This is the election year that should mean a lot to most of us. First there is the presidential campaign that has a lot of people not knowing just which way they will vote.

No matter what people say, I have to think that the presence of John Anderson in the race is merely to drain off some votes from Carter. One other fellow tried to run an independent campaign and he sank both his hopes and those of the man he wanted to beat.

George Wallace might have made things difficult for the two major parties if he hadn't got himself shot when he did. The difference between the campaign run by Wallace and that of Anderson

might make some people think, but not many. Wallace siezed on everything that was bothering Americans and wasn't above injecting racial prejudice, although he would deny in wide eyed innocence that he was a racist.

Maybe he wasn't but he used the theme for all he could. And in the time when George Wallace was running around the country, there was a lot for people to be concerned about. Riots and unrest were just about all over the country, and several people, including a few mayors and at least one local councilman ran against black unrest and won.

Wallace never took a direct position for or against anything that was bothering America. He would tell people how bad things were and promise that "You and me. We gonna shake things up in Washington." without ever saying how. And you would be surprised at the number of people who liked his approach.

Anderson seems to have a concrete program, but it is just about the same as people have been advocating for months. And his most concrete proposal, the fifty cent a gallon gas tax, would likely never get out of committee, so he could forget that. They won't even pass a dime a gallon tax.

It is said that he hopes to split the vote so that neither candidate can get a majority of the electoral

vote and thus give himself a slim chance. About the same chance a a snowball in Hades.

Here at home we have a constitutional convention to vote on and then there is the money to make the transfer of Tech High to North High. Most of the people I have talked to seem to be against the move, but they don't know why.

I recall that people were not exactly in favor of the first move of old West High to North in 1928. The move turned out to be a good one, and so might this latest one. The opposition to moving Tech seems to come from the fact that people tend to look down their noses at Tech, in spite of the fact that they have an enviable record of preparing youngsters for jobs and putting them in those jobs.

I can recall two houses that the Tech pupils built that are standing today after about ten or twelve years. Somehow Tech got a bad reputation that it didn't deserve any more than the rest of the city's high schools and folks still try to pin it on Tech.

You can find more law enforcement officers around Tech than you can around the rest of the high schools, and the pupils there are no worse or any better than they are around the city.

But any move has to be supported by money, and there is a quiet movement afoot to deny the funds for the move. Then what will happen? Like I said this is an election year, one of decisions.



## Thoughts and Comments

Community spirit and unity are two of the keys to a successful and effective response to a social, racial, political or economic challenge, regardless of its source. But organization and planning are at least as important.

Even if a group has sufficient "spiritual" unity to act in harmony in facing such a challenge without the overall direction of a detailed plan of action, its purpose is likely to fail. Leadership of such a group must be determined as soon as the decision is made to react to the stimulus, so as to provide the continuity and visibility to develop such an overall strategy and yet provide the remainder of the community with a means to provide input into the

process.

Additionally, this leadership must be reflective of all segments of the community, not just because all elements in the community are needed to present a strong and unified response to the challenge, but because the needs and interests of each must and are entitled to be represented to prevent division and dissention within the ranks. Most important, perhaps, is another factor which deserves more attention than I have yet given it.

The key to any successful community campaign may be stated in one word: unity. Without it, no social or racial minority group can hope to make any changes in the prevailing attitudes and practices of the community majority. Unless a group is unified sufficiently to prevent individual subcomponents of the overall group from fragmenting and diluting such effort.

The factor which has most hurt the efforts of our people to reach any goal they have set is that they have been too easily "bought off" or otherwise separated from the efforts of the rest. Far more often than not, either the leadership of or some segment of the group who is so dissuaded from participating creates sufficient disunity to make the attainment of the goal sought impossible.

The freeing of the slaves in 1863 threatened economic disaster to most of the slaveholders in the South and upset Northern bankers holding notes for considerable sums of money. It has been estimated that the state of Connecticut 'owned' the state of Georgia for many years after the Civil War. This relationship between Northern bankers and descendants of slaveholders sheds considerable light on the failure of the American government to keep its promise of forty acres and a mule to the freed. This failure set the stage for the return of former slaveholders to power by way of organized terror and violence of the Ku Klux Klan. White working men were recruited by Klan propaganda hinting loss of their jobs to Blacks. In 1871, Colonel George W. Kirk of the North Carolina state militia testified before a U.S. Senate Committee on Klan power in his state: "I have spoken of their having the law and courts on their side. The juries were made up of Ku Klux Klan and it was impossible ... to get justice before the courts".

During this era of night riders, resistance to the Klan was poorly organized, often because Federal troops who were the promised answer to the disorder never really stemmed the violence. In 1875 when a Black farmer stood before Senator George Boutwell and said his people were prepared to kill the Klan leaders, the Senator replied, "No, we intend to protect you." The betrayal of this promise forms a significant turning point in the U.S. history. An example of local resistance to Klan attacks took place a decade earlier in Marianna, Florida, and was probably duplicated in many other places during the era. Night riders terrorized a school for freed men and women. Finally, one night the forty Blacks and their white teacher brought guns and faced the night riders with determination and they rode off and never bothered them again. With the overthrow of Reconstruction and the return of southern government to "white supremacy" forces, Klan purposes were served by Klansmen in the robes of the executive, legislative and judicial branches of the government, and it was no longer necessary to wear sheets and ride at night. The descendants of the slaveholders were back in the seats of power. Few people, black or white, realize how active and

widespread the organizing efforts of the KKK became throughout the country in the decade of the twenties. This new Klan denounced not only Blacks but Catholics and Jews, foreigners, union organizers and radicals. The KKK dominated state government in Oregon, Oklahoma, Texas, Arkansas, Indiana, Ohio and California as well as in the Deep South. In Indiana, D.C. Stephenson, Grand Dragon of the half-million strong state KKK, proclaimed, "I am the law in Indiana." In Oregon, the Governor and the Mayor Portland attended a dinner for the state's Grand Dragon, the Governor speaking on "Americanism". By 1924 the KKK claimed a membership of five million.

In Queens, New York, during the 1927 Memorial Day parade, resistance to KKK organizing efforts was expressed in two forms. Controversy took place over the granting of a permit to the Klan to march with others. The Boy Scouts immediately withdrew and the Knights of Columbus (Catholic) organized a disruption of the Klan march. During the four-mile march, Klansmen were jeered from the sidewalk and several efforts were made to drive cars into their line. A series of scuffles escalated into a wild melee as charging residents stripped Klansmen of their sheets and drove them from the parade. It is, in my opinion, important to remember that the KKK was built on secrecy because it was based on the use of terror and violence. Those in power, ignoring the strong feelings of their constituents, chose not to

offend those capable of delivering or withholding a certain number of votes at election time. This view is best illustrated by the defeat of a resolution at the 1924 Democratic National Convention denouncing the Ku Klux Klan. This was the year Alfred Smith, a Catholic ran for U.S. President and was defeated. A victim of KKK religious bigotry.

The decade of the twenties was filled with anxieties concerning Black men returning from WWI in uniform expecting to be first class citizens, anxieties concerning labor organizing, anxieties concerning the meaning of revolution in czarist Russia. Americans were warned of Bolsheviks (Communists) from a foreign country here to undermine our government. Scapegoats were needed to absorb the blame for real and imagined dangers. This was a decade of largest membership for the Klan.

In spite of depressed conditions in the thirties, social crisis of the sixties, the Klan was unable to hold on to its maximum membership of millions. The 1930s and the 1960s were periods of mass movements advocating some real answers to social and economic problems, and there was a strong offensive against racism. The KKK made the mistake of attacking so many groups in the 1920s that finally decent people, both white and black, united against the viciousness of the Klan.

Strange as it may seem, the Ku Klux Klan is growing once again in the 1980s. Scapegoats are once

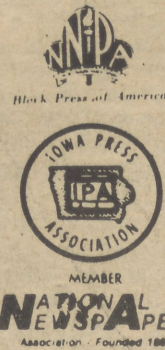

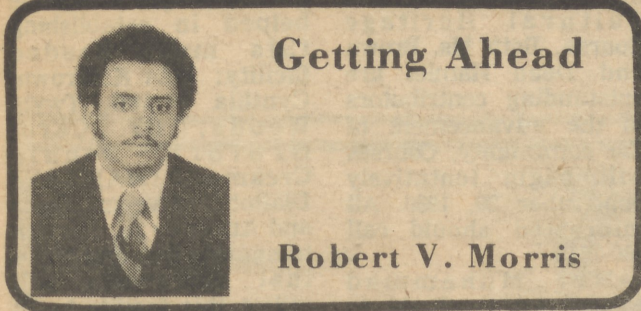

**Getting Ahead**

September 9, 1980 will be a day of major importance involving both the political position of black Iowans, and the current mood of white Iowans toward minorities in this state.

On this day an election will be held for two posts open on the Iowa City School Board.

Interesting events surround the election, and each candidate will represent an "entrenched" conservative element or a force for progressive change for the betterment of the total community.

The candidates are two black females - Classie Hoyle and Sandra Lockett, and two white males - incumbent N. Karagan, and L. Koch. All are running for two three-year positions on the school board.

Dr. Classie G. Hoyle is a resident of Iowa City, and the Affirmative Action Director for the University of Iowa. She has a daughter in the school system, and has more than ten years teaching experience.

Sandra Bokamba Lockett is also a resident of Iowa City and has several children in Iowa City schools. She is a documents librarian at the University of Iowa College of Law.

All four candidates are well qualified, but one issue stands before the entire election; that being that black parents in the Iowa City area are currently extremely upset by racist practices occurring in Iowa City schools.

During a "speak-out" given by the Iowa City Branch NAACP, over 40 black parents expressed their dismay at what one parent called, "racially insensitive policies and practices present in the Iowa City Public schools."

The speak-out led to an investigation by the Education Committee of the NAACP into racist incidents in the Iowa City schools. The committee's investigative report featured a multitude of discriminatory practices extant in the school district.

The report led to a broad racial discrimination complaint, filed by the NAACP, with the Iowa Civil Rights Commission. The complaint featured four broad points and the potential testimony of 25 witnesses.

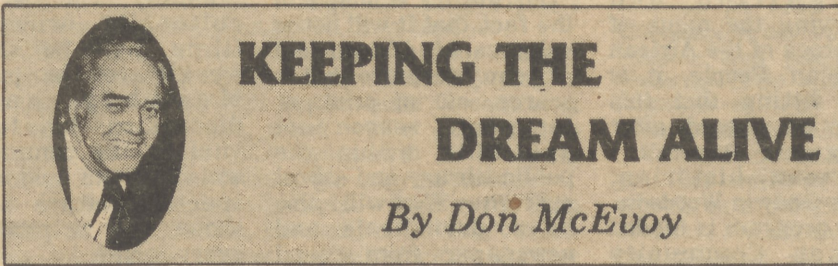
One of the main concerns of the black community

was the total absence of black administrators and policy makers in upper positions in the school district. As one black parent put it, "if policy makers are not sensitive to minority needs, how can policy be all-inclusive?"

It is clear that now is the time for Iowa City to make great changes for the better, to put a black face or faces on the School Board, and turn this city in a truly progressive direction.

I hope Iowa City's white community is objective enough to realize the importance of black citizens serving the School Board.

This is the only way to make Iowa City a fine place for everyone to raise their children - regardless of color. Whether in Iowa City, Des Moines, Davenport, Cedar Rapids or Waterloo, black Iowans should watch this election, because it could have repercussions that will touch us all.

**KEEPING AN EYE ON THE KKK**

Let's try to put the revitalized and newly visible Ku Klux Klan into perspective.

Klan rallies in a dozen states have sent shivers down the spines of millions of Americans of all races and creeds. Klaverns have been identified on Long Island as well as in Louisiana, in Southern California as well as South Carolina. After years of relative dormancy this spiteful phenomenon seems to be coming to life again with a vengeance.

Just how extensive and how serious is it? There is no doubt that Klan membership has grown in the past two or three years. The best information of actual membership (and I consider my sources to be fully reliable and accurate) is that there are at present 8,000 who have signed cards. These are divided among four groups and a number of local schismatic fringes. Of this number, there are probably no more than 1000 to 1500 who can be identified as fully committed hard-core Klansmen. Most of the others tend to drop-in and then drop-out depending on local circumstances and the social climate.

I am not underestimating the seriousness even of these small numbers, but there are some significant differences between today and those earlier periods of the Klan's heyday.

The KKK today has none of the political clout that is enjoyed in earlier manifestations. There was a time when the white community leadership strongly supported Klan activities. At least, they gave tacit approval to letting others do the dirty work for them. That is no longer the case. Almost universally the Klan is denounced by political, business and religious leadership.

Also, there is much more likelihood of local police action to arrest and willingness to prosecute than ever before. In other eras the Klan had the police, prosecutors and judges in its hip pocket. That is no longer true.

On the other hand, the current KKK leadership displays more tendencies toward violence than anytime in the past two decades. They are talking more openly about the possibilities of violence and have the weaponry to make this a reality. This is a very dangerous trend.

There is no cause for panic at this time. There is no imminent danger of the KKK having the kind of resurgence that made it the scourge it once was. Nonetheless, it is a time to be alert and watchful.

# Carter G. Woodson Center Opens

On August 4, 1980, the Carter G. Woodson Cultural Center for Human Achievement, Inc. opened its office to the Des Moines Community. The Center is located in room 203 of the Irving Multicultural Center (Tiny Tots) at the corner of 16th and Forest Avenue.

Shahid A. Muhammad, the Center Administrator says "The Woodson Cultural Center is a concept that is designed to effect change through cultural education. By Cultural education we mean that education that equips the individual with the tools for achievement in life's three most vital areas. 1. Self. 2. Family, and 3.

Community."

Carter G. Woodson is the Father of African American History and the founder of Negro History Month (1926). In the interest of recognition and preserving the name of the heroes of the African American People, it is most fitting that this center be named after the great African - American historian, Carter Godwin Woodson.

The program is funded through Community Development Block Grant Funds and though not limited to, will serve primarily the Woodland Wilkie / Model Cities Areas.

The Center will feature a library research dept.

which will house literature relative to African - American history, management and personality development.

Mr. Muhammad states "Our library is unique in the fact that it will house volumes of African and African literature that is scarce, out of print, or for some reason not available within the public library and school system. We will also have periodicals and newspapers from around the country that will keep us abreast of news and trends in the National community."

An additional feature of the library will include an audio - laboratory where the

public may listen to tapes on Positive Mental Attitude as well as lectures of great African American leaders such as Dr. Martin Luther King Jr.

Family, children and culturally orientated films will be shown weekly to the public. Monthly panel discussions on topics vital to the community will be held and as a special feature talent shows will be produced every month.

Muhammad said "the main thrust of the program will be the three courses offered at the Center. 1. Cultural Extensions - (African and African - American Heritage). 2. Successful parenting (Parenting Skills), and 3. Skills for Human Achievement - a social / survival skills course relating to job seeking / retention skills.

"We have professional people from within the Community who are in touch with the needs of the people who will be conducting the courses". Child psychologist and management consultant Ella K. Brown of Dynamic Management, Inc. will instruct the parenting skills class.

Zack Hamlet, Dean of the Urban Campus, will

have charge of the Cultural Heritage Course. Both Ms. Brown and Dean Hamlet are outstanding contributors to the advancement of the community. Courses will begin tentatively September 29, 1980. All interested should call 280-7510.

Mr. Muhammad expressed gratitude to

all the people who have helped in establishing this much needed facility: Etta K. Brown, Cynthia Powell, Twyla Woods, Dr. Carol Grufort, Bonnie Creamer, IMAM Ako Diallobe, Evelyn Davis and Attorney Al Parrish to name a few and hopes that community will utilize this facility to its fullest.

I cannot stand by and be a silent spectator, I have to raise my voice and speak out. I shall cry out, "Help, a community center is dying!"

I am ashamed to be part of a black community that has not lifted nary a finger or voice in the non-functioning of Gateway Opportunity Center. In these times of political unrest and Economic problems, where we as a race suffer more than any other ethnic group, we need all the facilities to train and keep the interest of our youth in advantages and racial pride. What can we offer our young if we have nothing to give them?

The family can only give them so much, the rest is left up to the community. If we turn our youth out into the street, they soon become victims of drugs, prostitution, all sorts of other crimes and general police harrassment. This is the major shame of any community.

These are the problems that a Community Center helps alleviate. It won't completely solve the problems, but every little bit helps. Where are the parents, the ministers, the Civil Rights leaders, and the Black Leaders of the community?

Where are you when you are sorely needed? Why do you hide from your responsibility? Where will our children go with time on their hands? What in the community besides home and school will they relate to growing up?

The white man has placed doubt of mistrust into our minds where there should have been none if the community had been more interested, a community that stood by and reaped the benefits without any input.

I have but one question to ask the Black Community of Des Moines, "Are you all



talkers, takers, dreamers, and glory seekers, but not givers? Think about it, for a Community Center is dying.

In this coming election year, I want the leaders of this community to remember, if you cannot help solve the problems

in your own community, how do you think you can solve problems of local, state, or federal government? Charity begins at home, I'm told.

Briefly, I had lunch again at JL'S FRESH BAR a few weeks back and was sorely disappointed in comparison to the first time we ate there. The food was O.K. but the silly, trippy, dippy waitress we had was extremely slow.

By the time our food arrived steam was coming out of my ears, my lip was stuck out, my toddler was about to have a fit and the assinine waitress had the nerve to comment on my daughter's "excessive energy". The hostess kept running back apologizing and offering my hungry child cookies to placate her.

On our way out she made the statement, "Your daughter didn't act so bad considering she had to wait so long for her food." "That's exactly why she acted the way she did" I snapped back. JL's Fresh Bar at Brandeis has lost another customer. Maybe your typical housewife has time to sit and wait an hour for lunch, I don't.

Another restaurant whose lunches are lacking is RAINTREE, formerly EDDIE WEBSTERS. Our waitress was very pleasant and relatively prompt, but the food itself was very mediocre. The salad was only O.K.

I had an extremely dry and tasteless piece of hamburger wrapped in bacon combined with a small fruit compote. My husband had a small steak that was small in taste also. I hope the RAINTREE's dinners are more satisfying than their lunches.

DUCKS & CO. at the Hyatt House is an entirely different situation. After thoroughly enjoying a Saturday night dinner with my husband; I went back for lunch twice last week while attending a conference on Fleur. The restaurant is a rather expensive one for Des Moines but very pleasant.

The drinks are especially high — \$5.50 for a Pina Colada and a Margarita, but tasty!! I didn't know grapes were your typical garnish for the former drink but what the heck. The salad bar at DUCKS & CO. is magnificent — one for the best and biggest I've ever seen.

Also the only one with shrimp, fresh broccoli and cauliflower spears and hot garlic bread on an adjacent grill. The accompanying dessert bar featured whipped cream, fresh strawberries and chocolate mousse to finish your meal, yum yum!!!

My husband decided on Scampi- served in a way I'd never seen: a creamy white sauce with zucchini and a unique form of potatoes that seemed to be both baked and fried. I enjoyed a large juicy New York strip. Two unique touches here: salad forks served in a chilled goblet with a carnation floating in it; plus a hot towel to clean sticky fingers after you've finished!

My only problem, all those duck pictures hanging on the walls rather gave me the willies. I'm not that fond of feathered creatures.

Last, some friends and I visited ZACHARY's in the new Breckinridge Hotel. I'd heard a number of negatives concerning the eatery such as high prices and so so food. I was none the less curious in checking it our first hand. The atmosphere is quiet, mellow and pleasant. The matre de was another pleasant little man who I think was trying to flirt or impress us with his savoirfaire. Our waitress was nice although rather slow.

There is no salad bar there. Your waitress brings you an extremely skimpy little salad and then wheels in a garnish cart with bacon chips, tomatoes, crutons, alfalfa sprouts, etc. to fill out your plate. We had to wait an extraordinarily long time for the latter. The drinks are ridiculous in price — \$3.25 for a grasshopper????!

Luckily, my dish, scampi was excellent. I received 5 huge fried shrimp atop a fresh pineapple half served with a beautiful peach colored sauce, a tasty vegetable and potato was included, although I was then too full to eat them. My dinner partners partook of prime rib and steak which they complained of being too fatty.

The after dinner drinks were all good. The prices, again here are rather hefty too. As I said, the atmosphere is rather staid, i.e., don't laugh or talk too loud; you'll get some nasty glares from some of the other parties.

Besides getting my check wrong 3 times we didn't get home till 11 o'clock. A four hour meal! So be sure you have plenty of time for dinner at ZACHARY's and remember, order the Scampi.

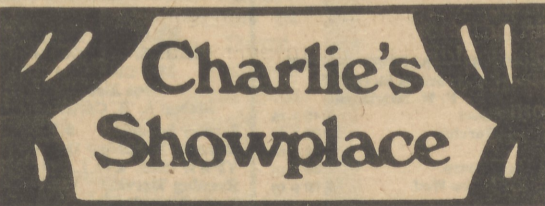

rather than six buildings. "We have new demands for fiscal responsibility," said Gentry, stating that the Tech - North move will save the school district money.

Gentry added that the move is a chance to upgrade the technical programs, and an opportunity to combine the college-bound students at both schools. With more students, said Gentry, it will be possible to re-institute courses that have been dropped due to low course enrollments, such as foreign languages and advanced math.

Palis stated, "I believe we have one too many high schools. The best possible solution is the merger. The Tech program, as well as image, can be improved. The North program can be improved."

He added that with a positive attitude on the part of people in the North area, there is "the greatest opportunity for this to be the finest school in the community."

Nepstad stated the reasons he is opposed to the Tech - North move. "It is not going to save money. It is very expensive." He predicted that the Tech High building, currently insured for \$16 million will probably be sold for \$1 million. He also claimed that the costs of running the new additions at the North and Irving campuses have not been estimated.

Nepstad also sees the move as hurting the North neighborhood. He said he believes the new school will not be as good as the present North High, because not one penny of the money raised by the tax levy will go toward improving the educational program.

**IF THE SCHOOLHOUSE TAX LEVY PASSES, WHAT SHOULD BE DONE FIRST BY THE BOARD, TO INSURE THE SUCCESS OF THE TECH - NORTH MERGER?**

Palis noted that what he sees as the first step, has already been taken, when the School District applied for and received nearly \$61,000 as a planning grant from the Federal government. The next step, according to Palis, is to look at and plan for the academic program at the new school.

Nepstad said that legally the School Board does not have to spend the tax levy funds on the Tech - North move; it can be spent on other things or not at all. He noted, that if elected to the Board, he would probably have to deal with the Tech - North move. In doing so, he stated, he would vote to cut out the move of the administrative offices to the Irving site, and would encourage spending the tax levy money for equipment,

repairs, and the educational program.

"I would make darn sure that the school is what it is billed to be — and then some," said Nepstad. He said he would be supportive of a strong academic program — "indeed a combined program, so that the North area would not be losing a high school."

Gentry said that the next step taken by the School Board should be to decide on "how wide open" the planning for the new school can be. He said he expects that a School Board work session to set the tone for future planning, will be held sometime in November. After that, he said, members of the community, along with the School Board, and administration, will be involved in planning for the new school.

**WHAT ABOUT SCHOOL CLOSINGS? SHOULD THEY BE TENTATIVE OR IDENTIFIED WELL IN ADVANCE OF CLOSING?**

Nepstad said, based on his experience as a realtor, the main factor determining where a family will buy a home, is the neighborhood school. He said the School Board's policy of targeting areas for school closings rather than naming the individual schools, has led to much uncertainty among residents.

Gentry noted that parents had protested identifying individual schools for closing, saying that such positive identification causes people not to move into the neighborhood — a self-fulfilling prophecy. Gentry said that is the reason the Board decided to identify areas rather than individual schools.

Palis commented that he had voted against the concept of naming areas rather than individual schools. But he added that it would be unwise to close a school just because it had been identified earlier for closing. When situations change, the decisions on school closings must be revised, according to Palis. He added, that of all decisions he has made as a member of the School Board, "closing schools is one of the most gut-jerking experiences."



# How to Drive Smarter and Save Gas

The family automobile is about to become a first line of defense in the battle against oil imports.

About one-third of all the petroleum used in the U.S. is burned as gasoline in passenger cars. Nearly half of it is imported oil, at a cost to the nation of \$10 million an hour or \$90 billion a year.

President Carter has said: "The high level of consumption of gasoline is the most important cause of our dependence on foreign oil. Our consumption of gasoline can be reduced with less serious consequences to our economy than if similar action

were taken with respect to other petroleum products, such as home heating oil."

The President set a goal of reducing gasoline consumption by 400,000 barrels a day, or 16,800,000 gallons a day by the end of 1980. He asked civic organizations, trade associations, unions, local govern-

ments, and employers to take the lead in encouraging people to drive less and to drive smarter—that is, to get more miles to the gallon.

Some of the ways to drive smarter are obvious—like observing the 55 miles-per-hour speed

limit. Most cars use 20 percent less gas at 55 than at 70. That's like saving 25 cents a gallon on the gas you buy.

Other gas-savers may surprise some drivers. For example, each two pounds of pressure that you add to your non-radial tires (up to the maximum stated on the tire) will increase gas mileage about one percent. And removing 100 pounds of excess weight can add as much as four-tenths of a mile per gallon.

The average car in the U.S. gets 14 to 15 miles per gallon, based on a mix of city and highway driving. And it travels about 11,000 miles a year.

This means it uses about 800 gallons of gasoline, at a cost of nearly \$1,000 (\$1.20 per gallon, and rising all the time).

That cost suggests a big opportunity for the smart driver who wants to save money.

There are two good ways to save gasoline. Both are easy, with a little planning and record-keeping.

**One:** Calculate how many miles you drove in the past 12 months. Set a goal of reducing that mileage, say by 20 percent. If you cannot estimate how many miles you drove, set your goal at some point below the 11,000 mile national average, and try to improve on it each

month.

**Two:** Set a goal of increasing your miles-per-gallon every three months, and promise yourself a dinner out or another reward every time you meet your mpg goal.

A 10 percent improvement should be attainable the first three months. This would be one-and-a-half miles per gallon if you now average 15. Five percent more, about seven-tenths of a mile per gallon, is reasonable for the next three months, because the first improvements are the easiest.

To monitor your miles-per-gallon, you must keep a record of the exact mileage and gallons each time you add gas. Then do your figuring over three fill-ups to allow for variations in driving patterns and different levels of "full." One tankful will not give an accurate measurement.

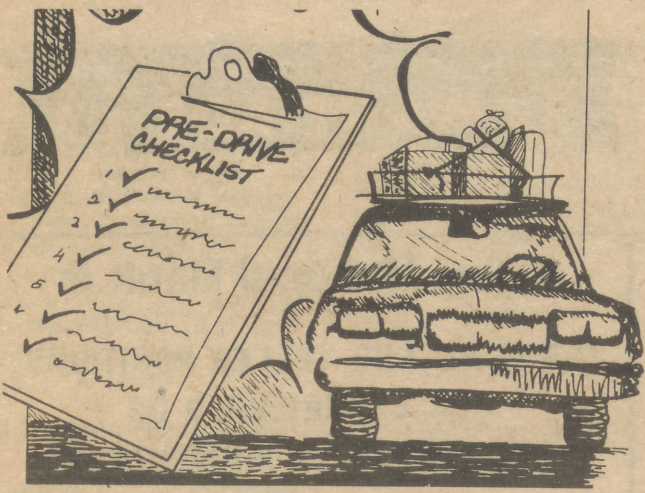
Use the first month's average

as your baseline, and try to improve it.

**ORDINANCE NO. 9817**

AN ORDINANCE to amend Ordinance No. 7226, passed by the City Council of the City of Des Moines, Iowa on July 12, 1965, as amended, by repealing Subsection (C) of Section 2A-28 thereof and enacting a new Subsection (C) of Section 2A-28, relating to procedure of the Board of Adjustment.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That Ordinance No. 7226, passed by the City Council of the City of Des Moines, Iowa, July 12, 1965, as amended by Ordinance No. 8522, passed January 22, 1978, be and is hereby amended by repealing Subsection (C) of Section 2A-28 thereof and enacting a new Subsection (C) of Section 2A-28, relating to procedure of the Board of Adjustment, as follows:

Sec. 2A-28. BOARD OF ADJUSTMENT: PROCEDURE.

(C) Appeals. Appeals to the Board may be taken by any person aggrieved or by any officer, department, board or bureau of the City of Des Moines affected by any decision of the Zoning Enforcement Officer or of any other administrative officer in the enforcement of this ordinance or of the zoning laws of this state. Each appeal shall be taken within a reasonable time as provided by the rules of the Board. The Zoning Enforcement Officer and any other officer whose decision is the subject of the appeal shall forthwith transmit to the Board all papers constituting the record upon which the action appealed from is taken.

An appeal stays all proceedings in furtherance of the action appealed from, unless the Zoning Enforcement Officer certifies to the Board, after notice of appeal shall have been filed with him, that by reason of the facts stated in the certificate, a stay would in his opinion, cause imminent peril to life or property. In such case, proceedings shall not be stayed otherwise than by a restraining order which may be granted by the Board or by a court of record on application on notice to the Zoning Enforcement Officer and on due cause shown.

The Board shall fix a reasonable time for the hearing on the appeal, give public notice thereof as well as due notice to the parties in interest, and decide the same within a reasonable time. At the hearing any party may appear in person or by agent, or by attorney. Before an appeal is filed with the Board of Adjustment, the appellant shall pay a fee to the City Treasurer to be credit to the general fund of the City of Des Moines according to the following schedule:

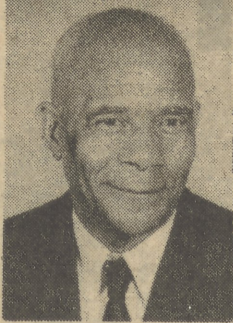

# ALLEN ASHBY with a LOOK ON SPORTS



As the gridiron season gets under way, I have to pause to reflect on the changes in the game as it was played when we were young and now. Of course, players played both ways on offense and defense, so you faced the same opponent in the line all day.

There were hosts of halfbacks weighing from one fifteen to one forty, and lots of hundred forty pound tackle and guards. If there wasn't a spot for a little guy, he was put out on the end, and sometimes did alright.

Kickers took one step instead of the number of steps they do now, and got the ball off quicker, but that would probably be a detriment to the fellows today because the ball would get downfield before the tacklers could get there. A favorite method of kicking, especially punting, was to stand with the kicking foot one full step in front of the other. Then the kicker would swing the kicking foot back as far as he could, and step into the ball. The speed with

which the kicks were gotten off made blocking one pretty hard.

When the ball was near the sideline, it was put in play right there just as long as it didn't touch the sideline. So teams had sideline plays and passes that sometimes worked and sometimes didn't.

Another feature was the fact that a player couldn't reenter the game in the same quarter that he left it in. So coaches used to take out players just before the end of the quarter or half and rest them so they could get back at the beginning of the next quarter or half. Teams like Notre Dame and the like used to send in their second team about five minutes before the end of the half, start them in the second half and let them play as long as they stayed out of trouble. Then the regulars came back in.

Blocking was an art. Coaches used to stress, "When you block, leave your feet." Now the poor devil would be left hanging in the air. It was the same in tackling. You were supposed to leave your feet to dive at a runner's knees. Any tackle above them was wrong, even if it was effective.

I have seen good ball carriers leave a string of as many as a half a dozen players strung out on the ground because they dove at the ball carrier's knees.

I don't think there were as many leg injuries then as there are now, because the runners could handle themselves. But then you didn't have a two hundred fifty pound guy hanging onto your neck. There were lots of little linebackers because most of the plays were running plays, with about one out of three or four plays passes. I can think of several real small fellows who were fine linebackers.

And substitutions. When a player came into the game, he couldn't even get into the huddle, had to stand at least five yards away until they lined up for the play. And he better not even move his lips because that meant a fifteen yard penalty. The coach couldn't say anything to his team as a team until between halves.

Sometimes, just before the end of a quarter or half, the coach would take out a player and tell him what he wanted to do, and put him back in at the start of the next time period. There was no coaching from the sidelines or nobody up on the top of the stadium sending in plays.

Teams, however, did get smart and had people up on the roof of the place who would come and report to the head coach between halves, and that helped sometimes.

Today I don't regard the games as a test of the teams entirely but which team has the best system of communication during the game, backed up by the fellows to do what you want.

Kicking? The ball was a bit rounder and somewhat larger than it is today. This made for drop kicking, dropping the ball on the ground and booting it on the rise. Some fellows could dropkick the ball as far as it could be place kicked or punted.

I saw a fellow drop kick one sixty yards at the Drake stadium. Now it is made for throwing, and with not so much emphasis on kicking.

You have to wonder how the players today would fare under the playing conditions of yesterday. Or how those old players would do with the smaller ball and the rules against blocking that they have now. It would be interesting to see what would happen.

## PLANNED PARENTHOOD CONTINUES ANNUAL PAP SMEARS FOR PATIENTS

Recent statements by the American Cancer Society about the frequency of the Pap Smear test for cervical cancer in women will not change the medical policies of the Planned Parenthood Federation of America. The Cancer Society suggested that women at lower risk of this disease did not need annual tests, since the condition develops slowly and could still be found and cured in time.

Women at higher risk for cervical cancer are those who began having intercourse before the age of 21, or who have had more than 3 sexual partners in their entire lifetime. Another group at risk is made up of those people who do not get regular preventive health exams, but see doctors only in an emergency.

Many Planned Parenthood patients fall into the higher risk category, and especially into the category of people who do not have regular preventive health examinations. Until there is some proof that Pap smears at longer intervals will not put these patients at

higher risk of undetected cervical cancer, Planned Parenthood will continue to require annual Pap smears for all patients, and more frequent tests for some people with unusual test results.

Planned Parenthood of mid-Iowa is a private, non-profit agency that provided birth control services, including cancer screening, to 14,671 patients in 29 Iowa counties during 1979.
