Gather at City Hall; Protest Sallis Case

Friday, June 3, many citizens of Waterloo demonstrated in front of and in City Hall to protest the handling of the Eddie Sallis case and conditions in Waterloo in general. The demonstrators stayed until the Mayor agreed to meet with representatives of the Negro community. That evening, Payne Memorial Chapel was filled with persons waiting to hear results of the meeting with the Mayor and to form plans for the future.

A list of persons to represent the Negro community in meetings with city officials was suggested, and met with approval of those present. Mrs. A. Weems, Dr. Warren Nash, Mrs. Ruth McKinnis, Mrs. Ada Tredwell, Rev. I. V. Tolbert, Rev. Jordon, Rev. Eugene Williams, Mr. Eddie Denton, and Mr. Roosevelt Taylor, all leaders in various groups in the community, will comprise the committee.

Rev. Tolbert presented a list of these 12 demands. Full investigation included public hearing, of the Sallis case; funded Human Rights Commission; removal of certain police officers and in-service training for public relations for police; removal of condemned houses and "disorderly houses" from north Waterloo; streets to be paved and lighting improved; Negro police and firemen be recruited; fair employment practices in sub-letting of city contracts; investigation of the policy and quality of schools; more city jobs for Negroes, investigation of hiring practices, especially in industry; enforcement of sanitation laws; Mobile St. crossing be left open; equal housing opportunity. The group discussed the list; approved, and agreed that this was a list of demands, not requests, and that they would not settle for just a partial compliance by the city administration.

Mrs. Eddie Sallis called me from Waterloo on June 2, 1966 at 7 p.m., and asked me to leave the White House Conference "To Fulfill These Rights" at which I was participating, and to fly immediately to Waterloo to represent her and investigate conditions which

had naturally shocked her and left her with great suspicions as to whether the administration of justice in Waterloo was being suitably carried out and enforced.

I have found the Waterloo authorities most co-operative in allowing me to examine the jail and to question some of the officers who

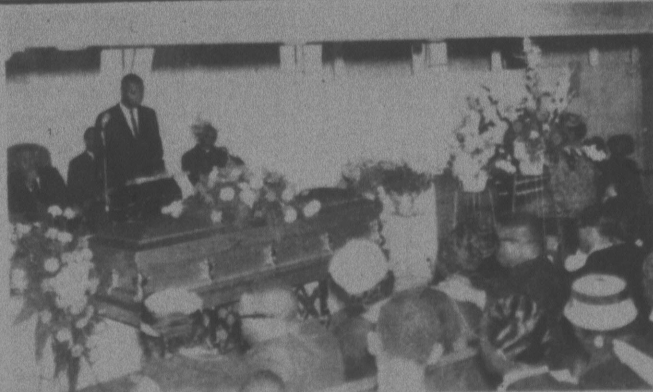

Supports Object Of Meredith March

Roy Wilkins, executive director of the National Association for the Advancement of Colored People, issued the following statement:

The single overriding issue in the shooting of James Meredith is that nothing in existing law or practice can protect a man anywhere in the Deep South from a race-inspired act of violence, or deter a would be attacker by the assurance of punishment. All the outrage, all the indignation, all the boiling anger we can summon will be of no value unless they produce action to correct this defect in the law.

Accordingly, we gave support to the march initiated by Mr. Meredith on June 5 and were represented by officers of our Memphis Branch on the first leg of that march, tragically interrupted by the shooting of Mr. Meredith.

We realize that recent gains in civil rights have been made possible by the support of the overwhelming majority of American citizens of all races and faiths. We welcome and expect their continued support.

The NAACP is convinced that bills now pending in Congress will provide Federal protection in cases like the Meredith assault, will end jury discrimination and will see to it that government makes adequate financial compensation to victims of racial assaults or to their families.

We continue to support the goals of the march as outlined by Mr. Meredith, goals which the NAACP has always espoused; increasing the Negro vote and lifting the pall of fear that hangs over southern Negroes, that is, protecting them against racial violence. Also the elimination of corrosive racism.

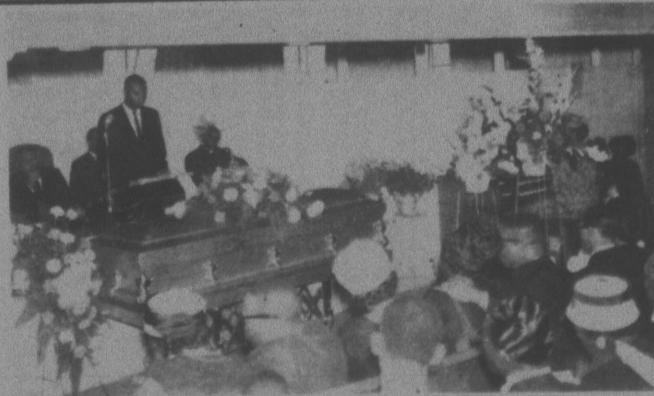

Saturday morning brought a drizzle of rain, but a good crowd met for the march on City Hall. Men, women and children of all ages, faiths and races marched together, signing "We Shall Overcome." Many carried signs pointing out grievances: some children wore signs "Don't Forget the Birmingham Bomb."

At City Hall, city officials listened to the reading of the demands, and comments of the Negro leaders. Mayor Turner said he could not comment on the list until he had time to study it. The marchers joined in prayer, and then quietly dispersed.

Saturday, June 11, a progress report meeting was called. Mrs. Weems, chairman of the committee, and other members, having met with city officials, told of constructive steps taken concerning most of the demands. Perhaps the most important and encouraging is the promise of the Mayor for a funded Human Rights Commission, and the recent addition of three members: Mrs. Sally McLendon, Rev. Ernest Ament, and Eugene Enderlein. With a Commission Director and Secretary, to be provided soon, Waterloo citizens will have an official place to go with complaints.

Persons desiring jobs with the city were urged to apply, take the test, and if they fail, were advised you should ask for the test, and you will then receive help in passing the test next time. The meeting was long, and some heated arguments arose, but free and open discussion is always preferred over non participation. Several persons emphasized that we must work together to insure success in this drive for justice.

Mr. Norman Sallis, cousin of the late Eddie Sallis, was present, and asked for persons willing to sign the declaratory suit against the city. Also, he is heading a fund suit. Mrs. Sallis, the widow, has said she needs no personal financial aid, but the family will certainly need help with the lawsuit.

One of the questions brought up repeatedly at the meeting was, "Where are the Negro ministers?" Admittedly, some may have had prior commitments, but this seemed to the group to be the most important place to be at this time. If the Negro ministers can't be relied on, must we turn to the white ministers? Indeed, where were they? Some must wonder what kind of religion Christianity is, to be preached safely on Sunday from a pulpit, or is it a faith to be lived all week long? Some commented they heard the ministers stayed away because they thought there might be trouble. That would seem to be the time and place to be seen.

Eddie Denton proposed the addition of two members to the committee; Father Tom Friedkin, of St. Mark's Episcopal, and Father Gregory, of the Catholic Student Center, C. F. The group voted to add them to the committee.

Father Tom had this to say about his appointment "I feel very honored that I have been asked to serve on this committee. I have been impressed by the responsible attitude that the committee has taken. I feel in a deeper way than ever before, lines of communication have been opened up between one of our minority groups and the city administration. Therefore, I will be very pleased to serve on this committee and help in any way I can."

Father Gregory said, "This certainly offers the opportunity for solid achievement for the overall improvement in the Negro Community."

**Mass Meeting
On June 25**

There will be a mass, open meeting June 25, 7 p.m., at Grant School. Present will be the Iowa Human Rights Community Director, James Thomas, who will then reveal his findings in the Sallis case. Also Donald Frey, the attorney from Evanston, Ill., who is handling the case. He will explain the declaratory action against the city. This will be an important meeting for all members of Waterloo, and it is hoped there will be a large turn out, and we will look for all members of the liaison committee to be present.

**Citizen's Committee
Meets Saturday**

Mrs. Ada Tredwell, President, has announced a public meeting of the Citizens' Committee of East Waterloo, Inc., Saturday, June 18, 7:45 in the J. Cosby Neighborhood Center, Oneida and Mobile St. On the agenda will be discussion of the immediate future of the center, funds for which are now available. The committee will also begin working on politics: voter registration and education and backing of candidates. Any person in Black Hawk County is eligible to join the group.

**State NAACP
Board Meeting**

Mrs. Helen Burke, Mrs. Martha Nash, Miss B. J. Furgerson, and Mrs. Paula Schwarz attended the State NAACP Board meeting June 4, arriving a little late because of taking part in the demonstration in Waterloo. Members from over the state had heard of the problems here, and were relieved to hear the situation was progressing well.

The Legislation committee made a report on the various civil rights planks they recommend, and some that counties have inserted in both party platforms. Hoped for planks include; fair housing laws, enabling legislation dealing with local Human Rights Committee, more minority group members on all state commissions, requirement of usage of multi-ethnic textbooks in all schools; grants to universities for study of urban problems, including public transportation, air and water pollution and race relations and elimination of Civil Service tests for state employment, as the tests are disadvantageous to minority groups. Iowa Branches will be visited by the new Region Four Director sometime in June. Plans are being made for the 51st State Conference, to be held in Fort Madison, Oct. 8-9. Mr. Louis Garland, State President, will confer with members of the Fort Madison Branch soon on the possibility of forming an NAACP Branch within the penitentiary. Mr. Hood, Director of the Des Moines Human Rights Committee, thanked the local branch for their support, and especially commended Mr. Bob Wright, Des Moines President for his assistance.

Support Passage of Civil Rights Bill



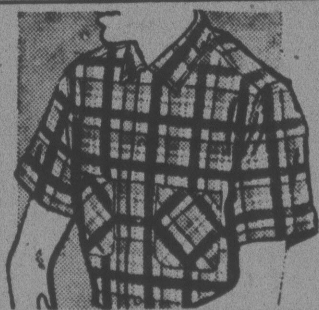

TEN REQUESTS BY GOOD CITIZENS OF WATERLOO

- 1) That the Waterloo present police force of 36 officers become integrated.
- 2) That all Waterloo public officials declare themselves personally in favor of equal opportunity for all citizens to the administration of justice, to housing, to employment, etc.
- 3) That a Human Relations Commission be established in Waterloo, made up of representatives with powers to investigate, to hold public hearings, to produce reports of their findings, and to make recommendations to the City Council.
- 4) That all public officials, including the police officers of Waterloo, be required to take courses in human relations and related studies.
- 5) That the entire public be educated as to what are the exact procedures to be followed by police officers in arresting people and in investigating alleged crimes; and what measures are taken to assure equal treatment.
- 6) That the City Council of Waterloo enact a Freedom of Residence ordinance declaring that no realtor, banker, builder, or property manager should deny to any citizen the equal opportunity to buy or rent a home wherever he can afford and wherever he wishes, declaring further that the ghettoization of cities must be eradicated as now seen as the central cause for mistrust and tension, based on ignorance and fear.
- 7) That pursuant to the recommendations of the recent White House Conference "To Fulfill These Rights", the Community of Waterloo, through its Human Relations Commission, consider the advisability of obtaining a federal grant-in-aid to finance the Police Department and the Housing Department to improve their basic structure so that all Waterloo may be made more livable.
- 8) That accurate statistics on crime in a community be collected and meaningfully and fairly interpreted by public and semi-public bodies so that the present distorted image of crime in ghetto areas of Waterloo be corrected and never allowed to develop again.
- 9) That a Community Equal Opportunity Council be formed on an interracial basis, involving all professions and occupations within the city, obtaining the support of public officials that the concept of equal opportunity is the business of the entire community; and that true improvement cannot be made without active and imaginative support on a continuing basis.
- 10) That the Community of Waterloo engage itself, as a whole, in the crusade to achieve (along with the whole nation) a new level of equal opportunity in accord with the dream of our founding fathers and pursuant to the highest Judeo-Christian convictions, and to this end engaging in practical and realistic means to achieve such goals in our life time through the use of the "special equal opportunity progress forms" provided by the Freedom of Residence Program.

Mr. Howard Sanders (who was with Mr. Sallis) and several witnesses who observed the arrest confirmed Mrs. Eddie Sallis' suspicions that there was certainly some rough treatment and some unusual handling of the two prisoners, and possibly some negligence. I am sure any human being would be upset and would call for an investigation and an attorney if her husband's body were embalmed so quickly without her consent and no autopsy made where there was such sudden death. Mrs. Sallis feels, of course, that she knew her husband very well and that never previously had he had any inclination to commit suicide. The police will verify that I insisted that Mrs. Sallis come with me to view exactly the scene of the events leading up to his death and to hear the officers' answers as I questioned them.

Certainly, you will agree that this approach was not intended to inflame anyone, but to try to arrive at the truth of the matter and to set people's minds and suspicions at rest.

We, therefore, requested an autopsy be made and talked with both pathologists who we understood would be involved with the autopsy. We have asked for a written report of the autopsy findings and have been promised such report although it is not yet received.

Now with respect to the statement in your editorial which reads, "Frey says he plans to institute a damage suit against the city." First you link this statement with my inaccurately quoted statement regarding "no evidence that police hung Sallis," which tends to infer that you regard a court suit as being inflammatory. Nothing can be further from the truth. It is the traditional American way to have questions of the responsibility of public officials and other citizens to maintain law and order and advance the best interests of the community through using the channels of the law courts. The law suit, in this case, is exactly what you are pleading for in the first paragraph of your proposed June 13 editorial, namely, "the endeavor must be undertaken with empathy, objectivity and a degree of patience." Mrs. Mary Sallis is a woman of the very best intentions. She feels that the conditions surrounding her husband's death are the very same conditions which the "survey team from the NAACP" was reporting upon. She feels that Count 2 of her lawsuit can do much to have these conditions corrected more rapidly than would be otherwise the case. The history of many communities reveals that the promises of public officials are not so rapidly fulfilled and implemented without some citizens in the same community taking the trouble (and rebuke from some other citizens) to start a law suit clearly spreading forth the desired long range objectives.

I think, in all fairness, that you should point out that it is not uncommon for "outside attorneys" or "out-of-the-community attorneys" to work in the matter which I have described. In matters like human relations and civil rights, it is extremely difficult for a local attorney to pursue for his client all of the rights that are developed and then at the same time retain the fellowship and amenities necessary with the public officials and other attorneys with whom he must work each day. Hence, the reason for often having an "outside attorney" to handle these delicate matters, and matters which can still be handled on a constructive basis and a traditional American basis.

I congratulate the Waterloo Courier for the fair way in which

it reported the purposes of the Mary Sallis law suit. Much space was given to the meaning of the "Declaratory Judgement County" in the suit. Incidentally, it takes money to develop a suit of this nature and Mrs. Sallis is gratified at the offers she has now received from citizens of the local community who are joining her in helping to pay for the expenses for the necessary investigations, court costs, etc.

I notice from your letterhead that your KWVL Television 7 station is connected in some manner with the "Blackhawk Realty Co.," and I, therefore, hesitate to mention what I believe to be the really important issue in the City of Waterloo, namely, the racial housing segregation. You will notice that the law suit and the "ten requests" bear down heavily on this basic problem. Our failure as a people in all communities of America has resulted in the undermining of all other advances in human rights and human relations. Just yesterday, Senator Sparkman's testimony in the U. S. Senate in opposition to the "Freedom of Residence Legislation" proposed by President Johnson shows how completely misguided and confused responsible people can be. He uses the phrase "the fundamental right of free property" to which I am positive your B.H. Realty Co. will subscribe. May I submit, in closing, that the really fundamental, basic, and absolute human right that we all have under our constitutional democracy is "the right to equal opportunity to life and property." Any citizen (public official or businessman or private house owner) who fails to carry out this right or who practices the denial of this right is, we submit, in violation of the 14th Amendment of the U. S. Constitution.

Station KWVL States Views

During the past few weeks, Waterloo has gone through an emotional experience that has directly or indirectly affected every citizen. A report from a survey team from the NAACP said that a large segment of the population on the North side felt strongly that they were being discriminated against in several areas of community life. Whether or not the survey was the catalyst that set in motion the ensuing period of racial unrest is not important now. But it did happen. Negro leaders submitted to the city administration a list of grievances, and conducted peaceful demonstrations to emphasize their unrest. Except for a few incidents perpetrated by hot-heads of both races, the episode has been peaceful. KWVL commends the Negro leaders and the city administration for their responsible approach to attempts to rectify any actual wrongs. Both sides approached the problem with level-headedness, and amicable attempts at solutions have begun. It is difficult at best for any society to correct in a short time all the wrongs that have been evident--or imagined--for a century and a half. Every possible means to correct evil must be exerted. But the endeavor must be undertaken with empathy, objectivity and a degree of patience. We believe this is the atmosphere that currently prevails now that closer lines of communication have been opened up.

At the same time we question the sincerity of Donal Frey, the attorney from Illinois, who represents the family of Eddie Sallis, the Negro man who was found dead in his jail cell last week. Despite the findings of an autopsy witnessed by responsible Negro leaders and city and court officials, that Sallis had committed suicide,

Frey says he plans to institute a damage suit against the city. In a lengthy statement to the press, Frey said "There is no evidence that police hung Sallis, and I certainly hope this is not the case." The very working of this and other statements, appear to be calculated to inflame passions rather than to temper tensions. . . . and came at the time leaders on both sides were attempting to effect harmony and accord. We believe Mr. Frey's appearance on the scene can do more to clog the present lines of communication than he may realize. If he were working QUIETLY on behalf of his clients it would be one thing. But his public statements--which have created suspicion, doubt and mistrust--is quite another.

KWVL hopes the leaders of the Negro community--who have thus far displayed commendable responsibility and sincerity--will consider carefully what motive Mr. Frey might have.

The history of many communities reveals that the promises of public officials are not so rapidly fulfilled and implemented without some citizens in the same community taking the trouble (and rebuke from some other citizens) to start a law suit clearly spreading forth the desired long range objectives.

I think, in all fairness, that you should point out that it is not uncommon for "outside attorneys" or "out-of-the-community attorneys" to work in the matter which I have described. In matters like human relations and civil rights, it is extremely difficult for a local attorney to pursue for his client all of the rights that are developed and then at the same time retain the fellowship and amenities necessary with the public officials and other attorneys with whom he must work each day. Hence, the reason for often having an "outside attorney" to handle these delicate matters, and matters which can still be handled on a constructive basis and a traditional American basis.

I congratulate the Waterloo Courier for the fair way in which

it reported the purposes of the Mary Sallis law suit. Much space was given to the meaning of the "Declaratory Judgement County" in the suit. Incidentally, it takes money to develop a suit of this nature and Mrs. Sallis is gratified at the offers she has now received from citizens of the local community who are joining her in helping to pay for the expenses for the necessary investigations, court costs, etc.

I notice from your letterhead that your KWVL Television 7 station is connected in some manner with the "Blackhawk Realty Co.," and I, therefore, hesitate to mention what I believe to be the really important issue in the City of Waterloo, namely, the racial housing segregation. You will notice that the law suit and the "ten requests" bear down heavily on this basic problem. Our failure as a people in all communities of America has resulted in the undermining of all other advances in human rights and human relations. Just yesterday, Senator Sparkman's testimony in the U. S. Senate in opposition to the "Freedom of Residence Legislation" proposed by President Johnson shows how completely misguided and confused responsible people can be. He uses the phrase "the fundamental right of free property" to which I am positive your B.H. Realty Co. will subscribe. May I submit, in closing, that the really fundamental, basic, and absolute human right that we all have under our constitutional democracy is "the right to equal opportunity to life and property." Any citizen (public official or businessman or private house owner) who fails to carry out this right or who practices the denial of this right is, we submit, in violation of the 14th Amendment of the U. S. Constitution.

Station KWVL States Views

During the past few weeks, Waterloo has gone through an emotional experience that has directly or indirectly affected every citizen. A report from a survey team from the NAACP said that a large segment of the population on the North side felt strongly that they were being discriminated against in several areas of community life. Whether or not the survey was the catalyst that set in motion the ensuing period of racial unrest is not important now. But it did happen. Negro leaders submitted to the city administration a list of grievances, and conducted peaceful demonstrations to emphasize their unrest. Except for a few incidents perpetrated by hot-heads of both races, the episode has been peaceful. KWVL commends the Negro leaders and the city administration for their responsible approach to attempts to rectify any actual wrongs. Both sides approached the problem with level-headedness, and amicable attempts at solutions have begun. It is difficult at best for any society to correct in a short time all the wrongs that have been evident--or imagined--for a century and a half. Every possible means to correct evil must be exerted. But the endeavor must be undertaken with empathy, objectivity and a degree of patience. We believe this is the atmosphere that currently prevails now that closer lines of communication have been opened up.

At the same time we question the sincerity of Donal Frey, the attorney from Illinois, who represents the family of Eddie Sallis, the Negro man who was found dead in his jail cell last week. Despite the findings of an autopsy witnessed by responsible Negro leaders and city and court officials, that Sallis had committed suicide,

Frey says he plans to institute a damage suit against the city. In a lengthy statement to the press, Frey said "There is no evidence that police hung Sallis, and I certainly hope this is not the case." The very working of this and other statements, appear to be calculated to inflame passions rather than to temper tensions. . . . and came at the time leaders on both sides were attempting to effect harmony and accord. We believe Mr. Frey's appearance on the scene can do more to clog the present lines of communication than he may realize. If he were working QUIETLY on behalf of his clients it would be one thing. But his public statements--which have created suspicion, doubt and mistrust--is quite another.

KWVL hopes the leaders of the Negro community--who have thus far displayed commendable responsibility and sincerity--will consider carefully what motive Mr. Frey might have.

Violence only belittles our cause and shows how narrow minded some people can be. If you really want to help the cause do as you are asked to do by our leaders.
