STATE ECOLOGIST NEEDED

There's an important vacuum in Iowa, the kind abhorred by Nature--we have no state ecologist. Dean Roosa resigned from that position several weeks ago, and may not be replaced unless concerned Iowans speak out. The position of the state ecologist is in the Bureau of Preserves and Ecological Services of the Department of Natural Resources. The Bureau used to have six staff members. One fulltime botanist was eliminated last year, and now that Dean Roosa is gone, four people are trying to carry what used to be a heavy work load for six.

Bureau work includes developing management plans for state preserves. The state preserve system was set up to protect some of our most valuable, high- quality natural areas. But money and staff for preserve management are limited. Some of Iowa's preserves, threatened by problems from outside their boundaries, and by their own small size need more help than they are getting. Unfortunately, the vacuum of an empty state ecologist position makes preserve planning and management even more difficult. It also hurts the critical effort to determine which Iowa plant species should be legally designated as threatened, endangered, or in need of special concern.

Iowa has lost more of its original landscape than any other state. Iowans depend on our state preserves to protect the best examples of our remaining natural heritage. We need to write to Department of Natural Resources Director Larry Wilson and Governor Terry Branstad and ask for a new state ecologist. ADDRESSES:

NOVEMBER 7 FIELD TRIP REPORT

A light snow was falling on Saturday morning as two Big Bluestem members made their way to Red Rock Reservoir. We met up with members of the Iowa Ornithologists Union and birded three locations at Red Rock. Sightings of interest included: Bonaparte's Gull, Hooded Mergansers, and Common Loon. Some I.O.U. members saw a Red-throated Loon that morning on the Reservoir.

ENGELDINGER MARSH

The Polk County Conservation Board has agreed to purchase 81 acres of marsh complex known as Engeldinger Marsh in northeast Polk Co. Funds for the project came from state wildlife habitat stamps and conservation groups. The property is split by U.S. Highway 65, the Des Moines-Marshalltown diagonal that Iowa Department the of Transportation wants to widen to four lanes through the wetland. That could destroy much of its value. Conservation groups are suggesting the I.D.O.T. build the road around the marsh or develop low impact alternatives which would cause minimal damage to the wetland, one of the few remaining "prairie potholes" in Polk County.

Letters urging the I.D.O.T. to protect the wetland would be helpful. Write:

AMES COUNT RECORDS

On the facing page are some past records of the Ames Christmas Bird Count. The column headed 1 gives the number of counts on which each species was seen in the 20 years from 1971 to 1990. Thus a 20 means it was seen every year, and a 7 means it was seen on seven counts over the 20 years. These numbers were abstracted by Jim and Steve Dinsmore. The second column, labeled 2 is the number of each species we found on the count last year, 1991.
