LEDGES STATE PARK

A letter was sent to Colonel Walter H. Johnson, District Engineer, Rock Island District Corps of Engineers, on behalf of the Ames Audubon Society to protest environmental changes anticipated in Ledges State Park by virtue of the Saylorville Reservoir. The letter was written by Lotus Miller, President of Ames Audubon Society. Several paragraphs from the letter are quoted below:

"Our members include many amateur naturalists, as are the nearly half million annual visitors to the Ledges. But whether a visitor enjoys wild living things or not, his enjoyment of the cool lower valley, the creek, and the sandstone cliffs which give the park its name are likely to be much diminished by the siltation and shifting in zones of vegetation brought about by more extensive flooding.

The Executive Board of the Ames Audubon Society believes that, of the alternatives listed by the Corps, the channel change barrier dam is the least destructive to the features of the park we wish to see preserved. In addition, we think that the procedures of regulating the water level should be changed so that there would be fewer days of flooding above the 870 foot level. Discussion of the tentative plan of operation and possibilities of change should certainly be included in the final Environmental Impact Statement.

We trust that, whichever alternatives are finally chosen, they will be carefully planned and conscientiously implemented to protect the Ledges State Fark for future generations of Iowans."
