#### AT LAST MONTH'S MEETING

At the Dec. 11 meeting, chapter members voted to purchase 300 trees to plant for wildlife along highway 30 east of Ames. The trees will be planted this spring in areas where previous years' plantings have died. Members also voted to pay the chapter's \$25 dues to The Nature Conservancy.

#### CHRISTMAS BIRD COUNT TALLY

Twenty-six persons participated in the Big Bluestem Christmas Bird Count on Dec. 15, which one birder termed "a pretty miserable day." The weather was cold and foggy with intermittant drizzle or hard rain. Despite these conditions, a total of 45 species of birds was seen with a total count of 7,428 individuals. Two new birds seen on this count were a Lesser Scaup and a Common Goldeneye at Hallet's Quarry. Birds seen during count week but not on count day included: Bufflehead, Common Merganser, Ring-billed Gull and Yellow-bellied Sapsucker.

Birds seen on Dec. 15 included: Canada Goose, Mallard, Lesser Scaup, Common Goldeneye, Red-tailed Hawk, Northern Harrier, American Kestrel, Ring-necked Pheasant, Common Snipe, Rock Dove, Mourning Dove, Great-horned Owl, Belted Kingfisher, Common Flicker, Red-bellied Woodpecker, Red-headed Woodpecker, Hairy Woodpecker, Downy Woodpecker, Horned Lark, Blue Jay, American Crow, Black-capped Chickadee, Tufted Titmouse, White-breasted Nuthatch, Red-breasted Nuthatch, Brown Creeper, Winter Wren, American Robin, Golden-crowned Kinglet, European Starling, House Sparrow, Meadow-lark species, Red-winged Blackbird, Common Grackle, Northern Cardinal, Purple Finch, Pine Siskin, American Goldfinch, Dark-eyed Junco, American Tree Sparrow, Fox Sparrow, Song Sparrow, Lapland Longspur, Snow Bunting.

### CONSERVATION/THE ENVIRONMENT

Baseball Diamonds Proposal -- At a meeting Dec. 13, the Ames Parks and Recreation Commission voted to postpone action on the proposed construction of baseball diamonds in East River Valley Park until other alternatives could be explored. The next meeting will be Jan. 14. One alternative that met favor with most conservationists at the meeting was a plan to construct the Little League diamonds in West Brookside Park, an area already considerably more disturbed than East River Valley Park. Drainage Again -- The question of whether or not drainage district projects should be exempt from state control will be an issue in the Iowa legislature this year after all. A change in interim committee sentiment means that a study of drainage laws by state and county agencies must be completed by Feb. 1, and legislative changes may be proposed before or after that date. Ames Reservoir -- Several Bluestem members attended a workshop held Dec. 12 to gather public opinion on the proposed Ames Reservoir and on water resource needs of this area. The forum was sponsored by the U.S. Army Corps of Engineers and was loosely organized, with about ten Corps representatives present to listen to comments and answer questions.

The society's Conservation Committee presented a written and oral statement listing items it would like to see included in a reevaluation study of the reservoir. Items included studying alternatives like greenbelt zoning, water conservation programs, erosion control through soil conservation and consideration of additional wells. Committee members also emphasized that public input throughout the study was vital.

Next the Corps will set up a committee to formulate alternatives to the proposed reservoir. Corps representatives will meet again in February with various interest groups, including Bluestem's Conservation Committee. Items to discuss with Corps personnel will be one topic of the Conservation Committee meeting on Jan. 28. Anyone interested in the reservoir is urged to attend this meeting.
