Iowa's Watchable Wildlife Guide by Bruce Ehresman Thursday, April 20, 7:30 pm, Room 2532, Veterinary Medicine Building, Iowa State University

Please join us for a presentation on a new guide which will be available this fall on Iowa's Watchable Wildlife. The guide covers 77 of the best areas in the state to watch wildlife. Bruce Ehresman will describe some of the sites and what to see at them and also tell us about how sites were chosen. Look for the guide this fall from Falcon Press.

Bruce Ehresman is a Wildlife Diversity Technician with the Iowa Department of Natural Resources at the Wildlife Station at Ledges State Park. Bruce is an Animal Ecologist and has been with the Wildlife Diversity Program (formerly Nongame Program) since 1980. He spent six field seasons working on the Breeding Bird Atlas Project for Iowa. Recently, in addition to the Watchable Wildlife Project he has been working on the Trumpeter Swan reintroduction project and a study of northeast Lowa neotropical migrant birds.

"Critters" - A Review

Saturday, March 18 was a rainy, cold morning but eleven Big Bluestem members turned out for a morning of birding at Little Wall Lake, Hallett's Quarry and Tieg's Marsh. The group was successful in viewing 17 species of waterfowl. They were: Canada and Snow Geese, Wood Duck, Green-winged Teal, Blue-winged Teal, Mallard, Northern Shoveler, American Widgeon, Canvasback, Redhead, Ring-necked Duck, Gadwall, Lesser Scaup, Common Goldeneye, Bufflehead, Common Merganser and Ruddy Duck. Thanks to Jon Bahrenfus for leading the group, and to the hardy birders who turned out for this trip.

Steve Dinsmore reports that on March 25, he had 20 species of waterfowl, including a Black Duck, on Anderson Lake, Tieg's Marsh and Little Wall Lake.

Story County Bird Sightings Needed

Steve Dinsmore, who has recently completed a compilation of *The Birds of Polk County* (available for \$3 from the author or the Des Moines Audubon Society) is now researching *The Birds of Story County*. It will contain information about all bird species' status in the county, seasonal abundance, breeding records, and other information. Information on uncommon or out-of-season birds in Story County is needed. Does a skunk in the cellar, raccoons in the garbage, squirrels in the bird feeder, or rabbits in the garden sound familiar? How about problems with canada geese, gulls, mockingbirds, bats, or swans? These are the chapter topics of a wonderfully readable new book by A.B.C. Whipple called, Critters: Adventures in Wildest Suburbia, published by St. Martin's Press in 1994. Each chapter is crafted in an engaging style, beginning with some practical experiences of the species in its human encounters. The author weaves a narrative examining the life history of the species and eventually presents a good practical philosophy of peaceful coexistence. His home is Connecticut, but much of his situation and attitude transplants well to Iowa and similar problems of people taking over animal habitat and vice versa. The ISU Parks Library has a copy at QH 541.5 C6W48 1994. I didn't check the Ames Library, but if it's there it should be at 591.52. How do you get a skunk out of the cellar? He sent his teenagers into the cellar making as much noise and confusion as they could muster. "Through the window I watched the skunk walk away, shaking his head in what looked like pure disgust."

An Environmental Bill of Rights

Did Americans intend to vote for dismantling 25 years of environmental legislation last November? Surveys would indicate that they did not, but a majority in Congress is acting as if they did. A truly alarming anti-environmental agenda is speeding through Congress, and unless there is widespread, powerful public protest, 25 years of environmental protection may be in shreds by year's end. At stake are protections for clean air and water, wetlands, and endangered species.

The National Audubon Society is joining with other groups to organize a citizens' campaign for an Environmental Bill of Rights. The goal of this campaign is to collect one million signatures pledging support for this Bill of Rights and to present Congress with this petition in the summer.

There are five main points in the Environmental Bill of Rights, all dedicated to the principle that every American has the right to a safe and healthy environment. They are: to prevent pollution, to preserve our natural heritage, to end give-aways of public resources, to conserve resources through sustainable technologies, and to reduce the influence of large contributors on the political process.
