You will notice that the program calls for no concurrent sectional meetings, but that the first evening is left open for special group meetings. Have you any group meetings to suggest?

THE MIDWEST WILDLIFE CONFERENCE

To be held at Madison, Wisconsin, Nov. 11-13. Memorial Union Building.

Purpose: To report new developments in the technology of wildlife management in the north central region. All conservationists are invited, but the subject-matter of the meeting is technical, i.e., it deals with questions of how to conserve (not whether to conserve) the game, fish, fur, songbird and wildflower resources of the region. It deals with work done, rather than work contemplated.

No formal proceedings are published, hence papers may be later repeated at the National Conference or at meetings of national scientific societies.

There will be no separate sectional meetings for specialized subjects. The program, however, reserves Thursday evening for groups who wish to call separate meetings

To assure time for discussion, speakers are asked to condense their presentations to 20 minutes as a maximum.
