All samples of corn entered in this contest must be entered in the name of the grower and must be grown in Sioux or Lyon Counties and in the year 1902.

RESOLUTIONS ADOPTED AT THE FARMERS' INSTITUTE

HULL MEETING

R solved that we extend a vote of thanks to the people of Hull and the vicinity to whom we are indebted for the excellent lunches and for our entertainment while here, and to the businessmen of Hull for the hearty cooperation and interest shown in making this a successful institute.

Be it resolved that the members of this institute and especially the executive committee extend thanks to all those who have taken part in the program and have helped to carry out same and especially would we thank Professor Holden for his very able service and instruct the Executive Committee to secure him for the next institute, if possible. And especially would we thank the ladies who read papers at the evening session. And be it further resolved that we hereby request our secretary to send greetings to our old time friend, Mrs. Jane Denby now at Jefferson, Oregon and extend to her our heartfelt thanks for her able paper read at the evening session.

Whereas, Roy Emory, the only one of the 8 boys who entered the corn growing contest, stuck to it right through to the end. Resolve that we, the members of the institute, congratulate him on the measure of success obtained in the past and worst season for corn growing that Sioux County had seen for many years.

Be it resolved that we favor the continuation of the boy's corn growing contest and that the Executive Committee be and are hereby authorized to again extend an invitation to the boys and girls too, to enter a contest in growing corn for a prize to be named by the Executive Committee and that a committee of 5, one from each supervisor district, be appointed at this meeting to solicite funds for the premiums.

Whereas, more that one-half of the people in Iowa are directly engaged in Agricultural Pursuits, and the only place in the State to which we can go for thorough training in the business of Agriculture is the Iowa Agricultural College and Experiment Station have been poten factors in placing Iowa in the lead as an Agricultural State.

Whereas, the lamented loss of President W. H. Beardshear, whose name we loved and whose great service to the people of Iowa, we greatfully acknowledge places the college in need of a worthy successor. Therefore, be it resolved that we the farmers of Sioux County in Institute assembled do express our belief that the man who is to be selected for the position of President of the Iowa Agricultural College should be, if possible, an Iowa man who is familiar with Iowa Agricultural needs and resources, and that either Secretary of Agriculture, James Wilson, or Professor C. F. Curtiss can more adequately than any other man preform the duties devolving upon this office.

R solved Further that a copy of those resolutions be sent to the President of the Board of Trustees of the Iowa Agricultural College and that they be published together with the proceedings of the Institute.

Whereas, it has been proposed to the members of the Sioux County farmer's institute now in session at Hull, this 18th day of February, 1903, to establish an experimental farm in Sioux County; and;

Whereas, it is believed that the Board of Supervisors upon request set aside a portion of the poor farm for such experimental farm, and appropriate money to purchase seed and to pay the extra expense incurred in carrying on such experiments as may be deemed best to be made and;

Whereas, Mr. Harry Makee, the present Superintendant of the poor farm has kindly offered his service as far as possible without any extra compensation.

Whereas, it is believed that such experimental farm will be of great value to the farmers of Sioux County. There

Therefore, be it resolved, that we favor such an experimental farm provided that first—the poor farm or a portion of it can be secured for the purpose. Second—that the money necessary for carrying on experiments can be secured. Third—that the experiments for the first year be limited to the growing of cereals, grasses, and vegetables. Fourth—that the amount of money to be expended be limited to \$250. Resolved further that the adoption of this resolution a committee of 2 be appointed to present this matter with a copy of those resolutions to the Board of Supervisors together with a plan of action.

CONSTITUTION ADOPTED

Section I. The name of the Institute shall be the Farmer's Institute of Sioux County, Iowa.

SectionII. Place of Meeting

The place of the meeting shall be in Hull in said county.

SectionIII. Nambership

Any person may become a member who is a practical farmer, retired farmer, owner of a farm, or farms, their wives, sons and daughters who are 18 years of age, and who are willing to devote time and money to the advancement of Agriculture. Persons becoming members shall sign the by-laws and have the right to vote in said institute.

Section IV. Quorumbe

Ten members shall constitute a quorum for transacting business.

Section V. Officers

The Officers shall consist of a President, Secretary, Treasurer, and an Executive Committee of not less than 3, outside of such officers.

Section VI Term of Office

These officers shall be elected by the Institute in each odd numbered year, and shall hold his office for 2 years and until his successor is elected.

Section VII. Duties of President

The President shall preside at all sessions of the Institute. Have a general supervision thereof and appoint all committees except the Executive Committee.

Section VIII. Duties of Secretary

The Secretary shall keep a record of the proceedings of each session of the institute. Shall meet with the executive committee on their request and keep a record of their doings, shall make reports to the institute of such nature as he may deem necessary for it's usefulness and preform such other duties as the institute may direct.

Section IX. Duties of Treasurer

The Treasurer shall receive all moneys belonging to the Institute and pay them out as is set forth in Section X keeping a just and true account of same. He shall make annual report to the president.

Section X. Duties of Executive Committee

It shall be the duty of the Executive Committee to fix the time set, to the right places for holding institutes, to employ speakers or assistant, consulting the Director of the weather and crop service as provided in Section 1679 Code of 1897 to make and provide programs, to audit all accounts against the Institute, and when found correct, to approve the same, and when so approved, the treasurer shall pay them and retain them as voichers. The Executive Committee shall also settle with the treasurer annually and make report of each settlement to the Secretary to be filed with his records in his office. They shall at the close of each Institute transmit to the County Auditor, proof of such institute having been held together with an itemized statement showing the manner in which the money appropriated by Section 1675 and amendments thereto has been expended. They shall also draw orders on the County Treasurer for the said money.

- Section XI. Resignations shall be made to the President and by the President to the Secretary.
- Section XII. The President shall fill all vacant offices by appointment, but a vacancy in the office of President shall be filled by the Secretary, except when the institute is in session and a vacancy has to be filled, it shall be filled by the Institute.

Section XIII. Political, Religious and social questions shall not in any manner be discussed or entertained by the Institute. The Institute shall in no way lend or give it's aid to any scheme or plan for advertising goods, wares, or merchandise. Neither shall it aid or assist any person, partnership, society or corporation by it's doings or by it's funds. All moneys of the Institute shall be expended strictly for the Institute as contemplated by the law organized and govening such institute.

Section XIV. Amendments

These by-laws shall be enforced immediately upon their adoption by the Institute when in session on a mojority of vote or a guorum of 21 members
