FHA LIFTS RESTRICTION ON TURNAGAIN AREA

MR. ELMER E. GAGNON, DIRECTOR OF THE FEDERAL HOUSING ADMINISTRATION, STATE OF ALASKA, ANNOUNCED TODAY THAT THE RESTRICTION RULING THE SO-CALLED NOMINAL AND HIGH RISK AREAS, INELIGIBLE FOR FHA MORTGAGE INSURANCE AS A RESULT OF THE 1964 EARTHQUAKE, HAS BEEN LIFTED. EFFECTIVE IMMEDIATELY, FHA IS WILLING TO ACCEPT APPLICATIONS IN THESE AREAS ON THE MERITS OF EACH CASE. NO CHANGES HAVE BEEN MADE IN FHA'S REGULATIONS LESSENING THE OBLIGATIONS OR INCREASING THE RIGHTS OF LENDERS AND BORROWERS. MORTGAGE LENDERS ARE REQUIRED TO MAKE KNOWN TO EACH APPLICANT THEIR RIGHTS AND OBLIGATIONS IN CASE OF FUTURE EARTHQUAKE DAMAGE TO THE PROPERTY COVERED BY AN FHA INSURED MORTGAGE.

- Area T -- The area known as Wendy's Subdivision and the land that lies North to the Inlet, plus the Southern Boundary as follows:

 Starting at Wendy's Way, Northern Lights to Telequana Drive, thence North on Telequana Drive to 27th Avenue. 27th Avenue to McKenzie Avenue. McKenzie Avenue North to Knik Avenue.

 Knik Avenue East to the Alaska Railroad.
- Area II Eastern Boundary. Unlet on I Street to approximately Eighth Avenue, thence diagonally Southwesterly intersecting L Street at approximately Ninth Avenue and all of the land lying West of said boundary plus the area known as Bootlegger's Cove.
