The flooding in the state has made birding difficult, to say the least. Only two reports were received this week.

In the southwest on the 18th at the IPL ponds south of Council Bluffs, nine LEAST TERNS and 3 PIPING PLOVERS were seen at the north pond, and SEMIPALMATED PLOVERS were at the south pond. In Fremont County, 800-1000 CATTLE EGRETS were estimated to be between Bartlett and Nebraska City.

In the central in Story County, WILLOW FLYCATCHERS and BELL'S VIREOS were report to be nesting at Doolittle Prarie north of Ames.
