NA, The best field mark in support of the identification is the yellow bill. The perception of pupil size and amount of white in the speculum seem more subjective. Unfortunately, the head shape was not described. According to the NGS Guide, the bill on Common Goldeneye is "rarely all dull yellow." In view of the far greater likelihood of the Common, and the difficulty of separating the two, we should probably take the conservative approach here.

NA, The only characteristic suggestive of Barrow's Goldeneye is the yellow bill. Female Common Goldeneyes generally have a black bill with yellow tip but can very rarely have an entirely yellow bill. There are subtle differences in the white wing patches between the two species, but they are visible only in flight. My references don't mention any differences in pupil size. The best distinguishing field marks for female goldeneyes are head shape and bill shape.

NA, Female Common and Barrow's are notoriously difficult to separate. Best marks are the head and forehead contours and bill shape. Bill color can be deep orange or yellow-orange in the western population in adult and all or partly dusky orange in imm. female.

NA, While the yellow bill is very suggestive of Barrow's Goldeneye, pupil size is not useful field mark. Head shape, bill shape, and angle of forehead must be noted to separate the goldeneyes. The differences in the amount of white in the wing are best noted in flight.

NA, Head shape and bill size are the most critical features in distinguishing Barrow's from Common Goldeneye. Neither was mentioned. Some Common Goldeneye females are said to have yellow bills. The difference in amount of white in the wing said to be subtle.

NA, Possible due to yellow bill, but no other field marks noted, such as head shape. Common Goldeneye on occasion can have a yellow bill.

NA, I need more complete details before I accept this bird.
