VOTE: 5-A-D, 2-NA

A-D, Not a long viewing period but acceptable.

A-D, Adequate descrption. Drawing helped.

A-D, Jist and overall gray color, plus wing profile fits Mississippi Kite. Other Kites would be more rare and show white

and gray.

A-D, We have two very similar sightings in this batch that raise a single question. Is an all gray raptor, presumably a Kite, that flies over, a Mississippi Kite? The question is made difficult by the possibility of Black-shouldered, which is also expanding its range towards Iowa. While it would seem other marks such as tail color would be seen, I will concede that the gray (compared to white) underparts should be sufficiently apparent to carry these.

NA, The description sounds like a Mississippi Kite; however, no details of plumage were seen. A "large" perched bird doesn't fit this species--large in comparison to what? Flight pattern and overall gray appearance suggestive, but are subjective. I would

judge this one as "probable".

NA, Slender bodied pale gray bird with narrow pointed wings is not nearly enough to conclusively say this was a Mississippi Kite, or even to be beyond reasonable doubt. There are other field marks which need to be seen to and documented for this kind of record.

A-D, About minimum details to determine this bird but adequate enough, I feel, to determine this as a Mississippi Kite due to size, shape, coloration, and flight pattern. I like Bill's "immediate impression" comments!

REVOTE: 3 A-D, 4 NA

NA, I am reluctantly changing my vote to NA on both kites (Record 91-06 and 91-05). The descriptions of both birds were very similar, as were viewing conditions. Both were very probably Mississippi Kites. However in the best interest of scientific record, and the need for undisputed information about the apparent increase in vagrancy and expansion in range, we should probably take the conservative approach.

NA, The vagrancy pattern is very supportive of Mississippi Kite, but the details are so sketchy that I must change my vote

to NA.

NA, I think we should err on the conservative side for a bird seen only briefly by an observer inexperienced with this species. A-D, More information on this bird would have been nice, but as a fly-by, the viewing time was short. Sufficient details were provided to indicate a Mississippi Kite was seen.
