## DOCUMENTATION OF EXTRAORDINARY BIRD SIGHTING

Species: Black-bellied Whistling-Duck; Number: 1

Location: 2 miles north of Columbus Junction, Louisa Co., Iowa

Date: probably early April to 4 May 1999

Name and address: Thomas H. Kent, 211 Richards St., Iowa City, IA 52246.

Others before/with/after: The bird was seen by Ted Allen and his brother (not by me). Ted could not remember the date that it was first seen—may have been late March or early April. He videotaped the bird on Sunday, but he was not sure which Sunday. He showed the tape to Bill Ohde and Ohde reported it to Jim Dinsmore. It is likely that the video was made on 25 April for two reasons: (1) Ohde likely reported it to Dinsmore promptly and the report was apparently received the last week of April and (2) The videotape shows some large green leaves. Jim Fuller and I viewed the tape on 5 May. We looked for the bird on 4 May before we had talked to Ted Allen, but Ted reported that his brother had seen it that day in the afternoon (after we had been there). We searched the pond and many nearby water areas for several hours on 5 May without finding the bird.

Habitat and circumstances: A backwater slough adjacent to highway 70 and close to the Iowa River.

**Description of bird:** The videotape shows a duck with long legs and long neck standing on a small log by the water. It had tan and black underparts, a gray face, dark cap, and orange bill. At the end of the sequence it is seen in flight with a large white wing patch. The legs looked dark to me, but we only viewed the tape once and I did not make notes.

Similar species: Fulvous Whistling-Duck lacks the gray face, orange bill, and white wing patch.

Any one have reservations?: The identification was obvious when we saw the first image of the bird. Although there was considerable camera movement, the image size and brightness were adequate to see the bird reasonably well.

Light: videotape taken from the house under shady or cloudy conditions; Distance: 50 yards (guess); Optics: video only.

Previous experience: I have seen this species once in Iowa and many times in Texas.

References before/after viewing: checked National Geographic Guide while writing this report.

Time of notes: none; Final typing: 2 days after viewing tape and talking to Ted Allen.
