About 12:45 P.M. I went out to look for Glaucous Gulls behind tailwaters of L&D (Lock and Dam) 19. Among approximately 1000 Herring Gulls, I noticed a single Glaucous Gull just behind a spillway chute.

Most conspicuous about the bird was the pure white wingtips, in strong contrast to those of the Herring's. The mantle was a very pale gray, also much paler than that of the Herring. The gray mantle of the wings became white along perhaps the last inch of the wing's trailing edge. The bill was conspicuously yellow. The legs were pinkish, or possibly orangish, or somewhere in between--it was hard to tell at the distance. The head was white. The tail was snow white. Generally and overall, the bird appeared very pale, almost white, especially in contrast to the Herring Gulls.

The size of the bird was quite similar to the accompanying Herring Gulls;-I did not notice any significant size difference.

Likexk the other gulls in the area, the bird wheeled about over the spilway, evident ly looking for fish. It spent much time gliding, occassionally dropping sharply to the surface after something.

Based upon the clearly defined gray mantle and yellow bill, I beleived this bird to be an adult.

--Late Note: When viewing the G. Gulls on the 13th, I noticed the wing shape of the gulls and recalled that this bird had the same feature, but I had forgotten to include it in this documentation. Like the gulls on the 13th, this bird had wings which seemed relatively broader, shorter, and more triangular than those of other gulls in the area. In contrast, wings of Herring and Ring-billed seemed porportionately longer, more narrow.

Similar species and how eliminated: White wingtips ruled out Herring Gull.
