WHILE SCANNING A LARGE GROUP OF FRANKLIN'S AND RING-BILLED GULLS LOUNGING IN A FIELD JUST EAST OF THE LANDFILL, WE SPOTTED A DARK-HEADED GULL FLYING IN WHICH HAD WHITE OUTER WEDGES ON THE UPPER PRIMARIES AND DARK SMUDGING ON THE UNDERWINGS. AFTER THE GULL LANDED WE COULD SEE THE DARK BROWN HEAD, RED BILL AND LEGS
