SENATE MEETING

Roll Call

37 out of the 40 seated Senators were present. Masri was absent. Grillot and Feilmeyer were excused.

Approval of the Minutes

on the March 20, 1996 minutes there was to be a motion to reconsider 95-118F by Feilmeyer.

Steve Elliot (Finance Committee): won't be enough money for new business next week, be aware money might run out.

Presentations

Tim Lane (Great Great Aunt is Carrie Chapman Catt): to speak about 95-013R- insights into her life, he respects those votes and apologies to those who are offended. She visited 35 different foreign countries during her lifetime. At one time she even thought to look into the study of ethnology. She worked to achieve the 19th amendment. She wanted peace, education, justice, and fairness for all individuals.

Goodman: move to rescind 95-013R needs a 2/3 vote to rescind. objection by McGriff.

Goodman: Catt did good things, no time to sift through this whatever is offending must be proved that that thing is offending, rational behind it, we choose what is gonna offend us, no proof that this women was a racist, racist because she gives facts, feels a deeper regret for what we did to Carrie Chapman Catt. Kyle Pierce(Student/Black Student Alliance): we did not choose this fight, reconsider bill will not stop us from feeling the way we feel, either historical interpretations other then their own, it was not OK because of the times, need more-confused by this whole process, if you give people support don't take it back. McGriff: perception is the key, admirable that she went to 35 countries, wish the message would have been carried to include black Americans, Catt Hall represent a mentality that we don't have to discuss anything when we are raising money. Goodman: she's not a racist, prove to me that she is not. Butler: (read quotes of Catt) those things are racist.

Cowger: this is saying we don't want to address this issue, opposed to recindment.

Goodman made a motion to postpone recindment until next week. Seconded by Obrecht.

Cowger call the question on the postponement, 16-19 fails to postpone. Tim Lane: interpret this differently, she was raped afer husbands death, she was angry, she changed and realized she was wrong, she grew, one of the greatest things for her honor women are deserving of the honor. Mack: she has nothing to do with me, she wasn't in America, needed concern and compassion in the South. Tannehill calls the question on the bill. Seconded by Waldron. fails to rescind 18-16, needed 2/3. President Mangan vetoed to override Senate decision.

### Comments from the President's Table

President Mangan: reason why veto the bill: felt that this would represent campus, convinced that students don't like the resolution, students are not perfect, forced to apologize for action of great aunt, how can we have power to judge historical figures? The GSB was in favor of rescinding but not the 2/3 so went ahead with the veto.

Obrecht: 95-141F (Helping Student Party Peaceful) wave the second read rule, seconded by Juhl. Cowger calls the question. Seconded by Obrecht. passes 22-10.

### Unfinished Business

#95-136F (Funding for the National Agri-Marketing Association Club Trip)

Conference in San Diego, California. Do not receive credit. Allen: pre-prof. Goodman: amendment to give \$400 instead of \$700. fails 12-15 to allocate 400 instead of 700.

Frantzen calls the question. Seconded by Cowger. Bill passes 19-9.

#95-137F (Funding for the Agricultural Economics Quiz Bowl Team)

asking for more money this year because are going an extra 500 miles. Cowger calls the question. Seconded by Hamilton. Bill passes 28-2.

#95-139F (Funding for Off-Campus Council Promotion and Organization Drive)

\$200 for flyers and radio advertising. Friday March 29. Hansen calls the question. Seconded by Tannehill. Bill passes 30-0.

#95-127F (Recognition of Excellence)

Goodman: new information, would like to reconsider to eliminate meal part. Look at this again, better decision. Cowger: the invitations are already in the mail. Frantzen calls the question to reconsider. Seconded by Obrecht. 19-12 passes to reconsider. Livingston: this is a moral decision, look at students as a whole, remove cabinet from bill-pay for themselves. Tannehill objects. Keister calls the question to remove cabinet. Seconded by Tannehill. 6-17 fails to remove the cabinet. Elliot: half eating half not does not work this way. Hamilton: add 37 Senators don't have to have a debt to take care of next year. Cowger: 40 seated senators deserve to eat nobody complained-vote to give food, deserve a meal. Baldwin calls the question to add the Senators on. Seconded by Powell. Passes to add senators on. Hansen calls the question on the bill. Seconded by Keister. Passes 29-4. Please pay for your own meal right away if you are planning on doing that.

#95-118F (Extravaganza)

motion to reconsider that bill, made hasty decisions. postpone because Feilmeyer is not present. Frantzen calls question to postpone. Seconded by Baldwin. 9-18.

#95-141F (Helping Students Party Peaceful)

Milburn: people should be able to figure out for themselves what they should and shouldn't do. Shelly: contact class that has previously done this, will not be doing it this year, tangible students benefit from it. Mark: this will be advertising to show how to have a good party, vital, or they will take away VEISHA. Baldwin: should not have to fund for Ames Police mistakes. Frantzen: motion to remove Country Kitchen for landlords. Seconded by Allen. Goodman: these are all small steps to preserve VEISHA. Livingston: keep the 200. Obrecht calls the question on the motion. Seconded by Cowger. motion fails. Livingston calls the question on the bill. Seconded by Cowger. Bill passes 17-16.

Juhl? would like to remove 95-140F (Funding for the Student Alumni Association Executive Council) not enough funds to pass.

#95-013R(Recognizing a Year Long Controversy) override the veto:

Allen: the resolution is an opinion, by President Mangan's veto it is saying that his opinion is better. Vote to override even though not in favor of the resolution. President Mangan: this is a system of checks and balances, it is also a legitimate representation of students. Tannehill calls the question. Seconded by Dummermuth. vote in favor of overriding 2/3 vote. 16-14 override fails.
